BACKGROUND:

On July 14, 2009, the Board of Supervisors approved a Loan Agreement for the use of NSP Funds with Habitat for Humanity Riverside, Inc. ("HFHR"), a nonprofit public benefit corporation, in the amount up to \$1,915,000 for financing of acquisition, rehabilitation and disposition of approximately eleven (11) single-family homes to qualified very low-income (VLI) first-time homebuyers (the "NSP Loan Agreement") within designated NSP Target Areas in the community of Rubidoux as defined in the County of Riverside Substantial Amendment to the 2008-2009 One-Year Action Plan.

On October 27, 2009, the Board of Supervisors approved a First Amendment for the use of NSP Funds to allow eligible properties to be 50 years old or less and must not be listed on, or eligible for listing on, the National Register for Historic Places.

HFHR is having difficulties finding eligible properties within the NSP Target Areas inside the community of Rubidoux and requesting to amend the NSP Loan Agreement and expand HFHR's work area to include NSP Target Areas in the community of Highgrove, as defined in the County's 2008-2009 One Year Action Plan. All other provisions of the NSP Loan Agreement will remain unchanged.

County Counsel has reviewed and approved as to form the attached Second Amendment to Loan Agreement for the Use of Neighborhood Stabilization Program Funds. Staff recommends that the Board approve the Second Amendment to Loan Agreement for the Use of Neighborhood Stabilization Program Funds.

SECOND AMENDMENT TO LOAN AGREEMENT FOR THE USE OF NEIGHBORHOOD STABILIZATION PROGRAM FUNDS

This Second Amendment to Loan Agreement for the Use of Neighborhood Stabilization Program Funds ("Second Amendment") is made and entered into as of the _____ day of ______, 20___, by and between the COUNTY OF RIVERSIDE ("COUNTY") and <u>HABITAT FOR HUMANITY RIVERSIDE</u>, INC. ("HFHR"), a California nonprofit public benefit corporation.

WITNESSETH:

WHEREAS, COUNTY and HFHR entered into Loan Agreement for the Use of Neighborhood Stabilization Program Funds ("NSP Loan Agreement") on July 14, 2009; and

WHEREAS, COUNTY and HFHR amended the NSP Loan Agreement ("First Amendment") on October 27, 2009; and

WHEREAS, under the terms and conditions of the NSP Loan Agreement, COUNTY agreed to lend up to One Million Nine Hundred Fifteen Thousand Dollars (\$1,915,000) of NSP funds to HFHR for individual financing of acquisition, rehabilitation and disposition of approximately eleven (11) single-family homes to qualified very low-income (VLI) first-time homebuyers in the County of Riverside (the "Project") which is further described in Exhibit A of the NSP Loan Agreement; and

WHEREAS, eligible properties must lie within the NSP Target Areas inside the community of Rubidoux, as defined in Exhibit A of the NSP Loan Agreement; and

WHEREAS, HFHR is having difficulties finding eligible properties within the NSP Target Areas inside the community of Rubidoux; and

WHEREAS, HFHR is requesting to amend the NSP Loan Agreement and expand HFHR's work area to include NSP target areas in the community of Highgrove, as defined in the County's 2008-2009 One Year Action Plan; and

WHEREAS, amending the NSP loan agreement will assist the COUNTY to fulfill its requirements under the Neighborhood Stabilization Program; and

WHEREAS, COUNTY and HFHR agree to amend the NSP Loan Agreement and include NSP target areas in the community of Highgrove in addition to NSP target areas in the community of Rubidoux.

NOW, THEREFORE, in consideration of the foregoing, and the promises and mutual covenants and conditions hereinafter set forth, COUNTY and HFHR do hereby agree as follows:

- The NSP Loan Agreement shall be amended from requiring "the Assisted Units for this Project must lie within the Target Areas of the community of Rubidoux" to "the Assisted Units for this Project must lie within the Target Areas of the community of Rubidoux and Highgrove."
- 2. All other terms and conditions of the NSP Loan Agreement remain unmodified and in full force and effect.
- 3. This Second Amendment may be signed by the different parties hereto in counterparts, each of which shall be an original, but all of which together shall constitute one and the same agreement.
- 4. The Second Amendment is not binding until approved by the Board of Supervisors.
