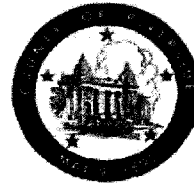

**RECOMMENDED MOTION:** That the Board of Supervisors:

1. Ratify change order No. 4 in the amount of \$500,000 to complete the project's Kitchen and provide a building security system;
2. Authorize the Assistant County Executive Officer EDA or designee to execute the change order on behalf of the County; and
3. Approve a revised project contingency of \$725,000.

**BACKGROUND:** On July 21, 2009, the Board of Supervisors approved the construction agreement between W.E. O'Neil Construction Co. and the County of Riverside for the Roy's Desert Resource Center, formerly known as, Desert Resource Center Build-Out.

**BACKGROUND:** (Continued)

Initial project funding was sufficient to plumb the facility to receive a full service kitchen, but insufficient to provide for the kitchen equipment and its installation. Until the kitchen can be completed, meals are prepared offsite and shipped to the facility at an increased cost per meal which means fewer families could be served. The project has now received \$500,000 from the Department of Social Services (DPSS) budget for the purpose of completing the kitchen and installing a building security system.

The shelter component of the project was completed in early December 2009, and put into immediate operation serving the Desert Region's Homeless population (meals are not currently prepared in the facility). The Contractor has been working on the kitchen infrastructure, and this funding will allow the completion of the kitchen utilizing both new and used kitchen equipment (to save cost) identified by the project's design team.

Change Order No. 4 will exceed the 10% contingency allowance, so Board approval is required. The change order will compensate W.E. O'Neil Construction Co. in the amount not to exceed \$500,000 for work essential to make the facility secure, and capable of preparing meals from its own kitchen.

Time is of the essence in completing the facility's kitchen as hundreds of additional individuals and families throughout Riverside County have become homeless due to current economic conditions (nearly half are woman and children). Public health and safety are best served in an economical manner when a Homeless Shelter can prepare food on site in direct proportion to the number of individuals who arrive each day in need of various services.

As such, it would not be of economic advantage to bid out this additional work at this stage of the project, particularly given the integral nature of the security system to completion of the infrastructure of the building, and the urgent need for services in the community. It is the County's intent to procure these items expeditiously via a change order to the general contractor. The project contingency amount of \$725,000 includes 10% of project contingency plus \$500,000 for the change order.

The Board of Supervisors approved all the necessary budget adjustments associated with this amendment without the use of contingency funds as part of the first quarter budget report on December 1, 2009 (item 3.34), and no further budget adjustments are required.
