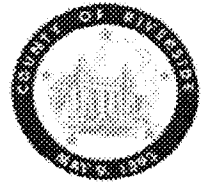

BACKGROUND:

On December 15, 2009 this Board received the Declaration of the Code Enforcement Officer in the above-referenced matter. At the conclusion of the hearing, this Board declared the accumulation of rubbish located on the subject property to be a public nuisance. The Board ordered the property owner to abate the violative conditions on the property and directed County Counsel to prepare the Findings of Fact, Conclusion and Order to Abate.

16 The above-captioned matter came on regularly for hearing on December 15, 2009, before the
17 Board of Supervisors of the County of Riverside, State of California in the Board Room, First Floor
18 Annex, County Administrative Center, 4080 Lemon Street, Riverside, California regarding the real
19 property described as Two Parcels North of 28295 Memory Lane, Winchester, Riverside County, and
20 further described as Assessor's Parcel Number 462-020-039 referred to hereinafter as "THE
21 PROPERTY."

22 Julie Jarvi, Deputy County Counsel, appeared along with Brian Black, Supervising Code
23 Enforcement Officer, on behalf of the Director of the Code Enforcement Department.

24 No one appeared on behalf of owner.

25 The Board of Supervisors received the Declaration of Code Enforcement Officer together
26 with the attached exhibits, evidencing the accumulation of rubbish on THE PROPERTY as a public
27 nuisance and violation of Riverside County Ordinance No. 541, as codified in Riverside County Code
28 Chapter 8.120.

1 **SUMMARY OF EVIDENCE**

2 1. Documents of record in the Riverside County Recorder's Office identify the OWNER
3 of THE PROPERTY as Menifee Valley Inv. Prop ("OWNER").

4 2. THE PROPERTY was inspected by the Code Enforcement Technician on April 15,
5 2009, May 22, 2009, September 1, 2009 and December 14, 2009.

6 3. During each inspection, an accumulation of rubbish was observed on THE
7 PROPERTY. The rubbish consisted of, but was not limited to: two large boats, couches, tables,
8 chairs, lazyboys, green waste, household furniture, household trash, clothes, wood, metal, plastic,
9 bottles, tires and miscellaneous items and measured approximately twenty nine thousand nine hundred
10 twenty (29,920) square feet.

11 4. THE PROPERTY was determined to be in violation of Riverside County Ordinance
12 No. 541 (RCC Chapter 8.120) by the Code Enforcement Officer.

13 5. A Notice of Noncompliance was recorded in the Office of the County Recorder,
14 County of Riverside, State of California on May 6, 2009 as instrument number 2009-0226206.

15 7. On April 15, 2009, a Notice of Violation was posted on THE PROPERTY. On April
16 15, 2009, a Notice of Violation was mailed by certified mail, return receipt requested to OWNER.

17 8. On August 31, 2009, a "Notice to Correct County Ordinance Violations and Abate
18 Public Nuisance" providing notice of the public hearing before the Board of Supervisors on December
19 15, 2009 was mailed by certified mail, return receipt requested, to the OWNER and posted on THE
20 PROPERTY on September 1, 2009.

21 **FINDINGS AND CONCLUSIONS**

22 WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in
23 regular session assembled on December 15, 2009 finds and concludes that:

24 1. WHEREAS, the accumulation of rubbish on the real property located at Two Parcels
25 North of 28295 Memory Lane, Winchester, Riverside County, California, also identified as Assessor's
26 Parcel Number 462-020-039 violates Riverside County Ordinance No. 541 and constitutes a public
27 nuisance.
