BACKGROUND/APPOINTEE INFORMATION:

On June 9, 2009 the Board of Supervisors amended the membership section (Section 5, subsection B.) of Ordinance 784 to reflect the appointment of six Commissioners and six Alternate Commissioners. Each member of the Board of Supervisors is to appoint one Commissioner and one alternate with the sixth being an At-Large appointment by the entire Board. These appointments are in addition to those of a member of the Board of Supervisors, the County Health Officer, and an individual responsible for the management of one of several enumerated County functions. The Alternate Commissioners will also serve as Advisory Committee members, in compliance with Proposition 10 statutes. The Ordinance specifies the qualifications for appointment, which includes a representative of a Local Medical, Pediatric, or Obstetric Associations or Societies in Riverside County. Mr. Stanley Grube is a representative of the Health Care Executives of Southern California and is currently president of the American College of Healthcare Executives Independent Chapter. Mr. Grube has had more than 40 years of experience in the health care industry serving most recently as CEO as well as various other capacities during his career. Mr. Grube has also served on the Ken Calvert Healthcare Advisory Committee and on the Riverside County Emergency Medical Care Committee. Mr. Grube will bring a wealth of experience to the Riverside County Children and Families Commission. Mr. Grube will serve as an Alternate to Commissioner Debbie Whitaker-Meneses.
