RECOMMENDED MOTION: That the Board of Supervisors:



BACKGROUND: (continued)

The appointed representatives of the VAC voted at its regular meeting on January 5, 2010 to remove Louis Morales from the VAC because of lack of attendance at meetings. His term expires June 30, 2010.
