SUBJECT: Acceptance of the FY 2009-10 Organized Automobile Fraud Activity Interdiction Grant from the California Department of Insurance and Adoption of Resolution No. 2010-043

RECOMMENDED MOTION: Move that the Board of Supervisors:

1. Approve acceptance of the Organized Automobile Fraud Activity Interdiction ("Urban Grant") Program award from the Insurance Commissioner of the State of California, Department of Insurance (DOI) in the amount of \$240,000, for the grant period July 1, 2009 through June 30, 2010.
2. Adopt Resolution No. 2010-043 authorizing the District Attorney to submit an "Urban" grant application to "DOI" and sign grant agreements on behalf of the Board through FY 2011-12. If funding of the grant significantly changes, is altered or discontinued, the department will return to the Board.

BACKGROUND: The Organized Automobile Fraud Activity Interdiction ("Urban") Grant is an ongoing program designed to investigate and prosecute organized automobile insurance fraud activity. Pursuant to the provisions of California Insurance Code Section 1874.8, the California Department of Insurance has awarded \$240,000 for the July 1, 2009 through June 30, 2010 grant period. This is the first year in a three-year funding cycle.

The attached grant agreement and resolution have been reviewed and approved as to form by County Counsel.


8 WHEREAS, the County of Riverside desires to undertake a certain program designated the
9 Organized Automobile Fraud Activity Interdiction ("Urban Grant") Program to be funded by funds made
10 available through and administered by the California Department of Insurance (hereinafter referred to as
11 "DOI"); now therefore,

12 BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of Riverside, State
13 of California, in regular session assembled on _____, 2010, that the Board of
14 Supervisors of the County of Riverside, State of California does hereby authorize the District Attorney of
15 the County of Riverside, State of California to submit and to sign Riverside County's application for grant
16 funding as well as related contracts, amendments, or extensions with "DOI".

17 IT IS AGREED that any liability arising out of the performance of this contract, including civil court
18 actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The
19 State of California and DOI disclaim responsibility of any such liability.

20 BE IT FURTHER RESOLVED that the resolution shall be in effect for a three-year period
21 beginning July 1, 2009 and ending June 30, 2012.

22 BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant
23 local expenditures controlled by this body.

GRANT AWARD AGREEMENT

Organized Automobile Fraud Activity Interdiction ("Urban Grant") Program



The Insurance Commissioner of the State of California hereby makes an award of funds to the **Riverside County**, Office of the District Attorney in the amount and for the purpose and duration set forth in this grant award.

This grant award consists of this agreement and incorporates by reference the grantee's original application for funding as supplemented and/or modified by the conditions attached to this agreement. By acceptance of this award, the grantee agrees to administer the grant project in accordance with all applicable statutes, regulations and this agreement.


Duration of Grant: The grant award is for the program period **July 1, 2009 through June 30, 2010**.

Purpose of Grant: The grant award is made pursuant to the provisions of California Insurance Code Section 1874.8, the emergency regulations adopted pursuant to California Insurance Code Section 1874.81, and shall be used solely for the purposes of prosecuting and eliminating organized automobile insurance fraud activity.

Amount of Grant: The grant award agreed to herein is in the amount of **\$240,000**. This amount has been determined by the Insurance Commissioner. However, the actual total award amount for the county is contingent on the collection and the authorization for expenditure pursuant to Government Code Section 13000 et seq. The grant award shall be distributed pursuant to Section 1874.8 of the Insurance Code and by the California Code of Regulations Subchapter 9, Article 5, Section 2698.73.
