SUBJECT: Approval of the Amendment to the Professional Medical Services Agreement between the County of Riverside and Elias, Elliott, Lampasi, Fehn, Harris & Nguyen, a Dental Practice, Inc.


RECOMMENDED MOTION:

BACKGROUND: On February 1, 2008, Elias, Elliott, Lampasi, Fehn, Harris & Nguyen, a Dental Practice, Inc., agreed to provide dental screening, treatment and education services to children under five (5) years of age as part of the First 5 Dental Grant awarded to RCRMC. This amendment revises the rate paid for general anesthesia and dental consultative services provided as part of the dental grant award.
