**SUBJECT:** Timeshare Internet Tax Sale, TC-187, scheduled May 4, 2010 through May 5, 2010.

**RECOMMENDED MOTION:** That the Board of Supervisors:

1) Approve the intended timeshare internet tax sale, TC-187 2) Approve and adopt the provisions of the Revenue and Taxation Code Section 3698.5(a), 3698.5(c) and Section 4703(a), 3) Adopt Resolution 2010-031 approving the sale of tax-defaulted property, prepared and approved by County Counsel, and 4) Instruct the Clerk of the Board to immediately forward a certified copy of the Board's Resolution to the Tax Collector following Board approval.

**The above action will authorize the minimum bid on timeshares to be offered for sale, via the Internet, scheduled for May 4, 2010 through May 5, 2010.**

**BACKGROUND:** Properties for which taxes are not paid are sold to collect back taxes. After the property has been tax-defaulted for a period of five or more years from the original tax-default year, it becomes subject to the Tax Collector's "Notice of Power To Sell Tax-Defaulted Property", which is then recorded. If the property is not subsequently redeemed by the payment of all amounts due, it is offered for sale by the Tax Collector. (Continued)

**BACKGROUND: (Continued)**

**SUMMARY OF THE TIMESHARE INTERNET SALE:**

**On May 4, 2010 9:00 AM through May 5, 2010 10:00 AM,** the Tax Collector will offer a total of three hundred (300) timeshare intervals in Club Trinidad Resorts, located in Palm Springs. These timeshare intervals have been requested by prospective purchasers to be placed on the sale and to be offered as a group. Since the resort has had some financial difficulties, these intervals are not good candidates at this time for sale to individual purchasers.

Three hundred (300) Club Trinidad Resort intervals will be offered for the first time for a minimum bid of full redemption, plus the \$540.00 cost of sale per interval. These intervals probably will not sell the first time offered because of the escalated minimum bid amount due to the several years of delinquent taxes and penalties that have accrued. These intervals will be grouped and offered as a single minimum bid of **\$849,642.00** (which includes cost of sale).

**On May 4, 2010 1:00 PM through May 5, 2010 10:00 AM,** the timeshare intervals that were offered for the first time on May 4, 2010 and did not receive a bid, can now be reoffered at a reduced minimum bid of \$540.00.

Assuming the grouped timeshare intervals do not sell on May 4, 2010 between 9:00 AM and 1:00 PM, three hundred (300) intervals will be reoffered on May 4, 2010 at 1:00 PM for the \$540.00 cost of sale each and grouped for a single minimum bid of **\$162,000.00**.

**SUMMARY OF THE TIMESHARE INTERNET SALE:**

For this sale, if all parcels reoffered sell for the minimum bid, the maximum tax loss would be \$197,917.81. Taking into account the Teeter formula, which shares this loss with other taxing entities, the maximum loss to the Tax Loss Reserve Fund would be \$107,330.83. A sufficient balance exists in the Tax Loss Reserve Fund to allow for this loss and still transfer to the General Fund the surplus amount included in this year's budget. Therefore there is no direct budgetary impact.

5      A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE  
6      APPROVING SALE OF TAX-DEFAULTED PROPERTY SUBJECT TO THE POWER OF SALE  
7      AND SETTING THE MINIMUM BID

8      WHEREAS, the Tax Collector of Riverside County intends to sell at public auction, over the  
9      internet, tax-defaulted property subject to the power of sale on May 4, 2010 through May 5, 2010 and  
10     requests that the Board of Supervisors of the County of Riverside, State of California, approve the intended  
11     sale and any postponement of the sale that may be necessary; the Tax Sale List TC 187 Sale File 4360 is  
12     attached hereto as Exhibit "A" and sets forth the property declared tax-defaulted with the year of the tax-  
13     default and the assessment number; the notice of the proposed sale will be sent to the State Controller in  
14     accordance with Section 3700.5 of the California Revenue and Taxation Code; and

15     WHEREAS, the Tax Collector in his discretion has determined that the property specified in  
16     Exhibit "A" attached hereto and incorporated by reference, should be offered for sale as a group, over the  
17     internet, starting at 9:00 a.m., on May 4, 2010 with the minimum bid to be in accordance with California  
18     Revenue and Taxation Code Section 3698.5; and

19     WHEREAS, California Revenue and Taxation Code Section 3698.5 provides that, where  
20     property has been offered for sale at least once and no acceptable bids therefor have been received at the  
21     prescribed minimum price, the Tax Collector may, in his discretion and with the approval of the Board of  
22     Supervisors, offer that same property at the same or next scheduled sale at a minimum price that the Tax  
23     Collector deems appropriate in light of the most current assessed valuation of that property or any unique  
24     circumstance with respect to that property; and

25     WHEREAS, three hundred (300) timeshare intervals, or less, at the Club Trinidad Resorts in  
Palm Springs will be offered as a group at the tax sale for the first time for the full redemption amount plus  
cost of sale, and if this group of timeshare intervals does not sell for the full redemption amount plus cost,  
the group of timeshare intervals will be reoffered as a group later in the same sale at a reduced bid which

1 the Tax Collector deems appropriate in light of the most current assessed valuation and unique  
2 circumstances with respect to the group of timeshare intervals; and

3               WHEREAS, the Tax Collector has determined that, due to unique circumstances, the group  
4 of timeshare intervals may not sell when offered for the first time and, in such a case, the group of  
5 timeshare intervals should be reoffered at the same sale at a reduced bid; and

6               WHEREAS, it is in the best interests of the State of California, the County of Riverside, and  
7 cities, school districts, and special districts for whom the Tax Collector collects taxes, to sell said  
8 properties; now, therefore,

9               BE IT RESOLVED, DETERMINED, AND ORDERED by the Board of Supervisors of the  
10 County of Riverside, State of California, that the above recitals are true and correct and that the proposed  
11 sale of tax-defaulted property subject to the power of sale and any continuation of the sale is hereby  
12 approved. Tax Collector of the County of Riverside is directed to offer the property, described in Exhibit  
13 "A" attached hereto and incorporated by reference, as a group, at public auction, over the internet, to the  
14 highest bidder for cash in lawful money of the United States at the minimum bid set in accordance with  
15 California Revenue and Taxation Code Section 3698.5(a) and 3698.5(c) as specified below:

16               1. Three hundred (300) Club Trinidad Resorts timeshare intervals, or less, will be  
17 offered as a group for the first time at a single minimum bid of the full redemption amount plus \$540.00  
18 cost of sale per timeshare interval. The minimum bid for the group of three hundred (300) Club Trinidad  
19 Resorts timeshare intervals, offered for the first time, will be \$849,642.00, which includes the cost of sale.

20               2. If the group of three hundred (300) Club Trinidad Resorts timeshare intervals, or less,  
21 does not sell at the full redemption amount plus cost of sale, the group of timeshare intervals will be  
22 reoffered later at the same sale at a single minimum bid equal to the cost of sale. The minimum bid for the  
23 reoffered group of three hundred (300) Club Trinidad Resorts timeshare intervals will be \$162,000.00,  
24 which is the sum of the \$540.00 cost of sale for each of the 300 timeshare intervals in the group.
