SUBJECT: First Amendment to the Capitated Primary Care (Medicare Dual Choice) Agreement between the County of Riverside and Inland Empire Health Plan (IEHP)

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the amendment to the IEHP Capitated Primary Care Provider Agreement with Riverside County Regional Medical Center (RCRMC) effective January 1, 2010;
- 2) Authorize the Chairperson to sign three (3) copies of the amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed amendments to Riverside County Regional Medical Center (RCRMC) for distribution;
- 4) Direct the Clerk of the Board to hold this Agreement as a confidential document, not subject to release under the Public Records Act, and Health and Safety Code Section, 1457 (C) (1).

BACKGROUND: Effective April 1, 2009, RCRMC agreed to provide health care services and participate as a primary care provider with IEHP's Health Access Medicare Dual Choice plan. Health Access provides health care services to members eligible for both Medicare and Medi-Cal benefits. The amendment increases the monthly capitation rate paid to the primary care providers and adds a \$300 Pay for Performance incentive for Annual Visits provided for Medicare Dual Choice members.

The Amendment has been approved as to form by County Counsel.
