

**SUBJECT:** Authorization to Provide Two (2) Years of Additional Service Credit to eligible Waste Resource Management District Employees covered under the Miscellaneous CalPERS Contract

**RECOMMENDED MOTION:** That the Board of Directors:

1. Authorize the Waste Resource Management District to offer two (2) years of additional service credit to all eligible employees covered under the District Miscellaneous contract and employed in an eligible classification (Attachment 2); and
2. Certify compliance with Government Code 7507 (Attachment 3) and Government Code section 20903 (Attachment 4); and
3. On March 16, 2010, Adopt Resolution 2010-01 (Attachment 5) and sign the Certification of Governing Body's Action (Attachment 6) to establish the window period in accordance with CalPERS requirements


Approval of this action will provide a retirement incentive for all Waste Resource Management District employees covered by the CalPERS Miscellaneous Plan who are over age 50 with five or more years of service. (continued)



**BACKGROUND:**

In January 2009, the Waste Resources Management District (WRMD) offered the early retirement option to 25 eligible WRMD employees. A total of 10 eligible employees retired (40% of those eligible) at that time. The cost of the additional service credit provided to the retirees and the immediate payout of leave accruals was included as a cost in Waste Management's budget. The positions vacated in the District will remain vacant providing a salary and benefit savings of \$806,279.

Today's action is proposed as a mitigation of layoffs. Based on previous historical declines in tonnage, staff is predicting an ongoing tonnage decline continuing to FY12/13 for an overall reduction of 40% from the peak. As an Enterprise Fund which operates almost entirely on tipping fee revenue, the current and projected reduction has significant impacts to the Department's fiscal outlook. Employees who elect the benefit will create vacancies in the Waste Management Department that can mitigate the impending budget cuts that will require elimination of one or more positions.

It is requested that the Board of Supervisors authorize the early retirement option to be offered to 17 eligible employees within the WRMD CalPERS contract who:

1. Have attained 50 years of age;
2. Have five or more years of service credit with CalPERS; and
3. Retire within the respective 180-day retirement window specified in Attachment 1.

The designated early retirement window period will be March 18, 2010 through September 13, 2010.

To implement this change it is necessary to provide two certifications to CalPERS, as provided in Attachments 2 and 3:

1. The Certification of Compliance with Government Code section 7507 (Attachment 2), which certifies the cost of this benefit is being made public; and
2. The Certification of Compliance with Government Code section 20903 (Attachment 3), which confirms the District's need to take this action, and that:
  - a. Impending layoffs constitute at least one percent of the District job classifications.
  - b. By this action it is the intent of the District to create unfilled vacancies thereby resulting in permanent overall reduction in the work force.

In addition, no earlier than two weeks after this public notice, this item must be returned to the Board's agenda for final adoption of the formal resolution and for signature of the Certification of Governing Body's Action.

Below we have provided cost estimates for this action, along with projected salary savings due to the resulting vacant positions. If all eligible employees within the proposed window period elect the early retirement option, the increased cost to the Miscellaneous contract would be approximately \$824,115. We believe 30% ( 5) of those eligible may accept the proposed incentive.

In this scenario (30% participation), the expected increase in the employee contribution rate is .38% of payroll beginning FY 12/13. The total service credit cost is \$ 247,234 or \$ 18,673 per year amortized over 20 years. The cost of the leave balances is an expense that will be incurred by the District upon the employee reaching standard retirement age and is not a cost associated solely with the early retirement incentive; these costs are disclosed due to their impact on the current year budget.

In summary, we recommend moving forward with an early retirement incentive for a 180-day window as a way to mitigate the impact of anticipated budget reductions. The results from the prior incentive have proven to be successful in reducing costs.

**CERTIFICATION OF COMPLIANCE WITH  
GOVERNMENT CODE SECTION 20903**

In accordance with Government Code Section 20903 and the contract between the Public Employees' Retirement System, the Board of Supervisors of the County of Riverside hereby certifies that:

1. Because of an impending curtailment of, or change in the manner of performing service, the best interests of the agency will be served by granting such additional service credit.
2. The added cost to the retirement fund for all eligible employees who retire during the designated window period will be included in the contracting agency's employer contribution rate for the fiscal year that begins two years after the end of the designated period.
3. It has elected to become subject to Section 20903 because of impending mandatory transfers, demotions, and layoffs that constitute at least 1 percent of the job classification, department or organizational unit, as designated by the governing body, resulting from the curtailment of, or change in the manner of performing, its services.
4. Its intention at the time Section 20903 becomes operative is to keep all vacancies created by retirements under this section or at least one vacancy in any position in any department or other organizational unit permanently unfilled thereby resulting in an overall reduction in the work force of such department or organizational unit.

THEREFORE, the Board of Supervisors of the County of Riverside hereby elects to provide the benefits of Government Code Section 20903 to all eligible members who retire within the designated period, March 18, 2010 through September 13, 2010.
