RECOMMENDED MOTION: That the Board of Supervisors schedule a public hearing for April 6, 2010 at 1:30 p.m., to obtain views of citizens and organizations concerning community development and housing needs for the County of Riverside's 2010-2011 One-Year Action Plan of the 2009-2014 Five-Year Consolidated Plan.

BACKGROUND: The County of Riverside is required by the U.S. Department of Housing and Urban Development (HUD) to develop a Five-Year Consolidated Plan in order to receive funding through the Community Development Block Grant (CDBG), HOME Investment Partnership, Emergency Shelter Grant (ESG), and other HUD programs. The One-Year Action Plan is developed annually by the County to identify those programs and activities to receive HUD CPD funding for the next fiscal year. The public hearing provides the opportunity for citizens, non-profit organizations, and other governmental agencies to comment on the One-Year Action Plan as well as the community development and housing needs of their communities.

Proposals for County-Wide Public Facility activities totaled \$800,000. Combined (HOME, CDBG, ESG) general management and administrative activities include oversight of consolidated programs (\$2,269,000).

RESUMEN EJECUTIVO.
