SUBJECT: Approval of the Amendment to the Professional Medical Services Agreement between the County of Riverside and Elias, Elliott, Lampasi, Fehn, Harris & Nguyen, a Dental Practice, Inc.

RECOMMENDED MOTION:

- 1) Ratify the Amendment to the Agreement with Elias, Elliott, Lampasi, Fehn, Harris & Nguyen, a Dental Practice, Inc., effective January 1, 2010;
- 2) Authorize the Chairperson to sign three (3) copies of the amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed amendments to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: Effective February 1, 2007, RCRMC was awarded a grant from the Riverside County Children and Families Commission, also known as First 5 Riverside, to provide dental screening and education services to children less than 5 years of age. The grant was renewed and funding increased effective July 1, 2009. As a result of this funding increase, additional dental services can be provided to children requiring care. Elias, Elliott, Lampasi, Fehn, Harris & Nguyen, a Dental Practice, Inc. has agreed to provide additional dental care and oral surgery services.

The Amendment has been approved as to form by County Counsel.

SECOND AMENDMENT
TO THE
PROFESSIONAL SERVICES AGREEMENT
BETWEEN
RIVERSIDE COUNTY REGIONAL MEDICAL CENTER
AND
ELIAS, ELLIOTT, LAMPASI, FEHN, HARRIS & NGUYEN
a Dental Practice, Inc.

That certain Agreement between the County of Riverside, on behalf of Riverside County Regional Medical Center, hereinafter referred to as HOSPITAL, and Elias, Elliott, Lampasi, Fehn, Harris & Nguyen, a Dental Practice, Inc. (CONTRACTOR) dated February 1, 2008 and amended effective July 1, 2009, is hereby further amended effective January 1, 2010 pursuant to the following:

1. Delete section 3.2 in its entirety and replace as follows:

Maximum payments to CONTRACTOR shall not exceed one hundred thousand (\$100,000) dollars per year. Payments to CONTRACTOR shall be made on a monthly basis during the Term of this Agreement.

All other terms and conditions of this Agreement are to remain unchanged.
