SUBJECT: Approval of the Amendment to the Professional Medical Services Agreement between the County of Riverside and Community Health Systems, Inc.

RECOMMENDED MOTION:

- 1) Ratify the Amendment to the Agreement with Community Health Systems, Inc., effective January 1, 2010;
- 2) Authorize the Chairperson to sign three (3) copies of the amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed amendments to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: Effective February 1, 2007, RCRMC was awarded a grant from the Riverside County Children and Families Commission, also known as First 5 Riverside, to provide dental screening and education services to children less than 5 years of age. The grant was renewed and funding increased effective July 1, 2009. As a result of this funding increase, additional dental services can be provided to children requiring care. Community Health Systems has agreed to provide additional dental care and oral surgery services for this program.

The Amendment has been approved as to form by County Counsel.

- 12 1. Delete section 3.2 in its entirety and replace as follows:

13 Maximum payments to CONTRACTOR shall not exceed one hundred
14 thousand (\$100,000) dollars per year. Payments to CONTRACTOR shall
15 be made on a monthly basis during the Term of this Agreement.

16 All other terms and conditions of this Agreement are to remain unchanged.
