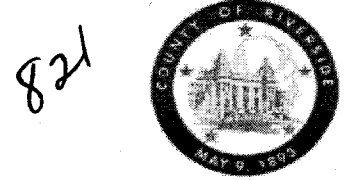

SUBJECT: Approval of the Second Amendment to the Professional Medical Services Agreement between the County of Riverside and Devin L. Anderson, DDS

BACKGROUND: Effective February 1, 2007 RCRMC was awarded a grant from the Riverside County Children and Families Commission, also known as First 5 Riverside, to provide dental screening and education services to children under 5 years of age. The grant was renewed and funding increased effective July 1, 2009 to provide additional dental treatment. Devin L. Anderson, DDS agreed to provide additional dental treatment for this program.

In consideration of services provided by CONTRACTOR, pursuant to this Agreement, CONTRACTOR shall be entitled to receive payment by HOSPITAL for all authorized services in accordance with HOSPITAL policy and procedures as follows:

1.0 Professional Services

- General Anesthesia \$500

All services are considered inclusive of technical fees charged by dental office.
