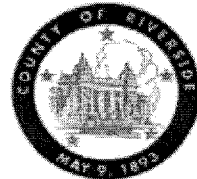

**SUBJECT:** Construction of Clinton Street from Miles Avenue to Fred Waring Drive, Indio area.

**RECOMMENDED MOTION:** That the Board accept the low bid of Cooley Construction, Inc. of Hesperia, CA in the amount of \$2,924,295. Award the contract to that firm and authorize the Chairman of the Board to execute the contract documents. Amend the TIP by approval of the proposed project budget shown on Attachment A.

**BACKGROUND:** By Minute Order dated April 6, 2010 (agenda item 3.76) the Board authorized the Clerk of the Board to advertise for the construction of Clinton Street from Miles Avenue to Fred Waring Drive, Indio area. Bids for the project were opened in the office of the Director of Transportation at 2:00 PM, Wednesday, April 28, 2010. Seven bids were received. The Transportation Department's established basis for the selection of a contractor is the lowest

responsive and responsible bid for all schedules of work. The lowest and best total bid was submitted by Cooley Construction, Inc. of Hesperia, CA in the amount of \$2,924,595. The total bid price, submitted by Cooley Construction, Inc., is \$1,239,015 (29.76%) below the Engineer's Estimate.

The widening of Clinton Street represents the third and final phase of a project to construct the Miles Avenue bridge over the Whitewater River (Phase 1 award; January 15, 2008, Item 3.45), widen Miles Avenue to four lanes from the Whitewater River to Clinton Street (Phase 2A award; February 24, 2009, Item 3.54) and widen Clinton Street to four lanes from Miles Avenue to Fred Waring Drive (Phase 2B).

The principle scope of work (Base Bid Schedule) is being financed by the County of Riverside, City of Indio, and the Coachella Valley Association of Governments (CVAG) under the terms of a cooperative agreement executed between and among the County of Riverside, City of Indio and CVAG (September 4, 2007, Item 3.39). This cooperative agreement includes a provision for CVAG to provide a loan to the County for funding of its portion of the project with reimbursement to be made, by the County, over a period of 10 years.

The project is within both the City of Indio and the County of Riverside. This final phase of the project will reconstruct and widen Clinton Street between Miles Avenue and Fred Waring Drive to provide four through lanes of traffic and modify the traffic signals at:

1. Clinton Street and Miles Avenue
2. Clinton Street and Palmyra Avenue and Lyndon B. Johnson Elementary School

The traffic signal modifications will provide protected traffic movements and improve traffic safety.

The award documents include the following schedules of work:

Base Bid: Primary items of work.

Alternate A: Domestic water line extension and improvements, adjustment of water valve covers and the relocation of fire hydrants. This work is the responsibility of the Indio Water Authority. However, the County will fund the work in exchange for road improvements previously performed by the City on County right of way on Clinton Street.

Alternate B: Manhole adjustment, to be funded by Valley Sanitation District, under the terms of a letter agreement to be executed prior to or concurrently with the submission of the construction contract for award.

Alternate C: Construction of conduits, transformer pad and a medium manhole enclosure, to be funded by Imperial Irrigation District, under the terms of a letter agreement to be executed prior to or concurrently with the submission of the construction contract for award.

We have requested concurrence from each utility owner and anticipate approval to award the alternate bid schedules as bid by the apparent low bidder. These alternate bid schedules are therefore included in the submitted contract for award. The costs for the work to be performed under Alternate Bid Schedules "B" and "C" will be funded by the respective utility owners. In the event that the utility owners do not provide final approval, these items will be deducted from the contract and the work will be done by the utilities.

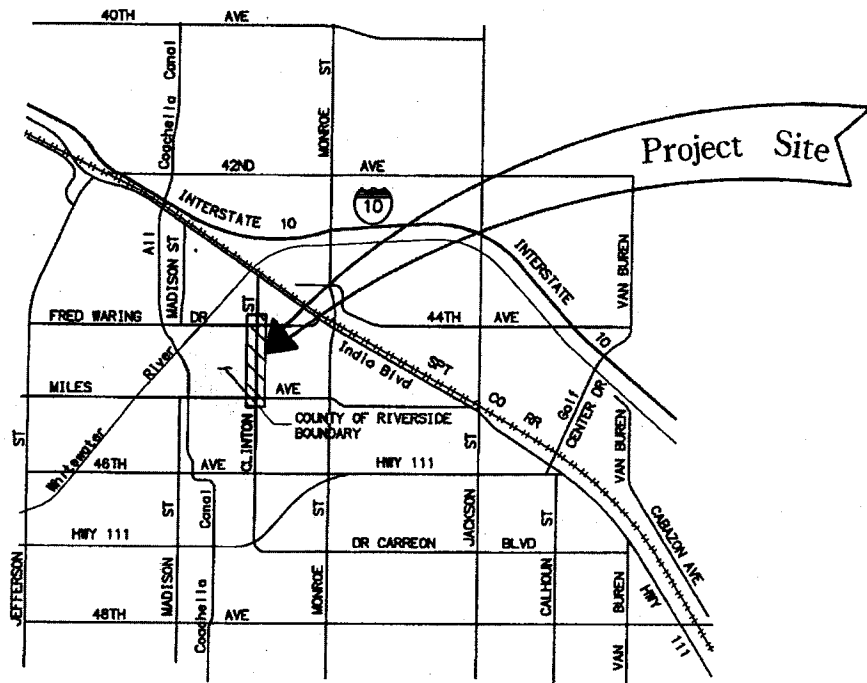
The Contractor is in the process of executing the contract and providing bonds and insurance documents. There is great urgency on the part of the City of Indio to have us do this work this Summer while school is on break. Approval of this Form 11 will allow the Contractor to start ordering material ahead of the final executed contract. The Contractor is qualified.

A cooperative agreement was executed between the County, CVAG and the City of Indio on September 4, 2007 as item 3.39. Terms of that agreement provide that CVAG front CVAG's 75% share of costs plus the 12.5% County share and the 12.5% City share. County and City shares are to be paid back to CVAG over a ten year period, with interest. The first installment is due the fiscal year after completion of all work, which will be FY 11/12. The Transportation Department will program reimbursement to CVAG as part of the annual Transportation Improvement Program using District IV Road Funds. Annual installments for all three projects are estimated to be \$275,000, subject to final costs.

### Comments

In order to reduce construction cost and accelerate construction, the project will be constructed in 3 phases. Phase 1 will construct the Miles Avenue Bridge across the Whitewater River. Phase 2A is the construction of the roadway and storm drain improvements along Miles Avenue. Phase 2B is the construction of the roadway and storm drain improvements along Clinton Street.

The costs shown for Preliminary Survey, Environmental, Design, Right-of-Way and Utilities are for the Phase 1, Phase 2A and Phase 2B work. The costs shown for Construction (including contingency), Construction Engineering & Inspection and Construction Survey are for Phase 1 and Phase 2A work only. Projected Costs for construction includes the construction estimated cost for Phase 2B (\$3,217,000) and the balance to pay for the improvements of Phase 1 and Phase 2A.

CVAG will reimburse 75% of total cost and the County and the City of Indio will equally share the remaining 25%. CVAG will upfront 100% of the total cost and the City and County have executed an agreement to reimburse CVAG for their share over a 10 year period.

## AGREEMENT

### WITNESSETH

#### RECITALS:

1. Contractor has submitted to County his Contractor's Proposal for the construction of County Project, **Clinton Street in the City of Indio and County of Riverside Street Improvement Plans, Project No. B2-03892**, in strict accordance with the Contract Documents identified below and County has accepted said Proposal.
2. Contractor states that he has reexamined his Contractor's Proposal and found it to be correct, has ascertained that his subcontractors are properly licensed and possess the requisite skill and forces, has reexamined the site and Contract Documents and is of the opinion that he can presently do the work in accordance with the Contract Documents for the money set forth in his Proposal to be paid as provided in the Contract Documents.

#### AGREEMENT:

#### IT IS AGREED BY THE PARTIES AS FOLLOWS:

1. Contract Documents. The entire contract consists of the following: (a) The Agreement. (b) The Notice Inviting Bids. (c) The Instruction to Bidders. (d) The Contractor's Proposal. (e) The Bid Bond. (f) The Payment Bond. (g) The Performance Bond. (h) The General Conditions. (i) The Special Provisions. (j) The Standard Specifications of the State of California Department of Transportation edition of May 2006 as modified in other portions of the Contract Documents. (k) The Standard Plans of the Department of Transportation identified on the plans or in the Special Provisions. (l) The Plans. (m) Addenda **No.1**. (n) The Determination of Prevailing Wage Rates for Public Work. (o) Any Change Orders issued. (p) Any additional or supplemental specifications, notice, instructions and drawings issued in accordance with the provisions of the Contract Documents. All of said Documents presently in existence are by this reference incorporated herein with like effect as if here set forth in full and upon the proper issuance of other documents they shall likewise be deemed incorporated. The Bid Bond is exonerated upon execution of this Agreement and the Payment Bond and Faithful Performance Bond.
2. The Work. Contractor shall do all things necessary to construct the work generally described in Recital No. 1 in accordance with the Contract Documents.

3. Liquidated Damages and Time of Completion. Attention is directed to the provisions in Section 8-1.06, "Time of Completion", and in Section 8-1.07, "Liquidated Damages", of the Standard Specifications and these Special Provisions.

The Contractor shall begin work within 15 days of the date stated within the written "Notice to Proceed".

The Contractor shall notify the Engineer, in writing, of his intent to begin work at least 72 hours before work is begun. The notice shall be delivered to the Transportation Department's Construction Engineer and shall specify the date the Contractor intends to start. If the project has more than one location of work, a separate notice shall be given for each location.

Should the Contractor begin work in advance of receiving a written "Notice to Proceed", any work performed by him in advance of the date stated in the "Notice to Proceed" shall be considered as having been done by him at his own risk and as a volunteer and subject to the following:

- (1) The Contractor shall, on commencing operations, take all precautions required for public safety and shall observe all the provisions in the Specifications and the Special Provisions.
- (2) All work done according to the contract prior to the issuance of the "Notice to Proceed", will be considered authorized work and will be paid for as provided in the contract.
- (3) The Contractor shall not be entitled to any additional compensation or an extension of time for any delay, hindrance or interference caused by or attributable to commencement of work prior to the issuance of the "Notice to Proceed".

4. Compensation. Contractor shall be paid in the manner set forth in the Contract Documents the amount of his Proposal as accepted by County, the above rates, subject to additions and deductions as provided in the Contract Documents. Said Proposal is on file in the Office of the Clerk of the Board of Supervisors of County.
