SUBJECT: Support for Expansion of Foreign Trade Zone 244

RECOMMENDED MOTION: That the Board of Supervisors authorizes the Chairman of the Board to sign the attached letter of support for modifications to Foreign Trade Zone 244 (FTZ 244). Further the Board directs the Assistant County Executive Officer-EDA, Managing Director-EDA, and or County Foreign Trade Commissioner-EDA, to work closely with the staff and leadership of FTZ 244 to promote further development and investment of FTZ 244 and the creation of new jobs for the county workforce and monitor the progress of the application to the Foreign Trade Zone Board.

BACKGROUND: The County of Riverside is a voting member of the March Joint Powers Authority. Primary representatives of the County are the Chairman and Vice Chairman of the Board, representing districts 1 and 5 respectively. In addition to the County of Riverside, the organization is comprised of elected representatives from the cities of Perris, Moreno Valley, and Riverside. FTZ 244 offers specific incentives to manufacturers physically located within the FTZ that reduce taxes, tariffs, and fees associated with importing products for manufacture within the County of Riverside.

FTZ 244 has not enjoyed the support of the Department of Homeland Security or the United States Department of Commerce on recent attempts to expand the FTZ due to staffing concerns relating to customs officers. The county has actively engaged in the Congress, Senate, and Department of Homeland Security in recent months to address the issue of providing staffing and continues to advocate for such staffing.
