**SUBJECT:** Exclusive Care - EPO Second Amendment to the Medical Contractor Agreement with Homan Abdollahzadeh, M.D.

To provide services to its enrolled members, Exclusive Care has contracted with a variety of healthcare providers.

The Medical Contractor Agreement (“Agreement”) between the County of Riverside, State of California (“County”) and Homan Abdollahzadeh, M.D. (“Contractor”) for health care services effective July 1, 2008 through June 30, 2013 for Exclusive Care enrollees, is hereby amended effective March 1, 2010 as follows:

1. All references in the Medical Contractor Agreement between Homan Abdollahzadeh and County of Riverside – Exclusive Care EPO referring to “Homan Abdollahzadeh, M.D.” shall now be referenced as “Homan Zadeh, M.D., M.P.H., Inc.”
2. The tax identification number for Homan Zadeh, M.D., M.P.H., Inc. also effective March 1, 2010 is 900529510.
3. All other terms and conditions of the Agreement shall remain in full force and effect.


