Zone 1

For fiscal year 2010-11, there is no proposed increase in the assessment for Zone 1. The proposed assessment for fiscal year 2010-11 for Zone 1 of the District is \$178.52 per acre. The actual rate property owners pay is based on the parcel size and there are 450 parcels.

Zone 1 was established 13 years ago with an assessment of \$178.52 per acre per year and did not establish an inflation factor. The proposed budget for fiscal year 2010-11 is \$14,544.

Zone 3

consistent with the ballot proposition approved by the qualified electors when establishing said zone. The proposed assessment for fiscal year 2010-11 for Street Lighting Zone 95 of the District is \$188.56 per acre and there is 1 parcel, which aggregates to 1.82 acre(s).

Street Lighting Zone 95 was established 1 year ago with an assessment of \$181.32 per acre per year. The proposed budget for fiscal year 2010-11 is \$343.
