Progress Report

This report summarizes the County of Riverside and the design team's accomplishments and decisions reached over the past quarter. It also identifies upcoming project activities for the Riverside County Regional Detention Center (RDC) project.

CEQA/EIR - Master Planning & Programming:

- A) The comment period for the Draft EIR officially closed on January 15, 2010. The County received approximately 60 comments. The primary substantive issues raised in the comments include:
 - · wildlife movement corridor linkage impacts
 - global climate change
 - tourism impacts
 - · water resources
 - public safety
 - · property values
- B) After reviewing the comments, it was decided that additional studies regarding the wildlife movement corridor linkage should be included in the Draft EIR. AECOM and LSA are commencing those studies.
- **C)** AECOM is in the process of designing an undercrossing at the Stubbe Canyon crossing of Tamarack Road. Currently, this is the only active design work on the project. All discussions with utility companies have been stopped pending the outcome of the Draft EIR.
- D) AECOM and the County are working with Caltrans on the design of the wildlife undercrossing.
- E) LSA will be performing surveys for the Stubbe Canyon Wildlife Undercrossing.

Design Documents:

Design documents for the RDC are currently on hold.

Future Business:

AECOM will continue to work with the County on the design of the Stubbe Canyon undercrossing. LSA will be analyzing the environmental effects of the undercrossing.
