BACKGROUND: The Agreement sets forth the terms and conditions by which certain stormwater drainage facilities, required as a condition of approval for Parcel Map 35933, are to be constructed by the Developers and inspected, operated and maintained by the District. The Agreement is necessary to provide for District construction inspection of the Eastvale MDP – Line E Black Horse Street Laterals associated with Parcel Map 35933. Upon completion of project construction, the District will assume ownership, operation and maintenance of the mainline storm drain.

The Developer is funding all construction and construction inspection costs. Future operation and maintenance costs will accrue to the District.

County Counsel has approved the Agreement as to legal form and the Developers have executed the Agreement. A companion item appears on the Flood Control District's agenda this same date.
