A job order was issued pursuant to the contract for supplemental work, for removal of existing fuel lines for the original generator, removal of non compliance fuel lines, backfill trenches, compaction testing, and asphalt as required per Safety and Health Department Code. The work was located in the parking lot at the Indio CAC in the amount of \$9,300.

The job order has been inspected and found to comply with all contract requirements. This Board action will release the balance of the retention funds of \$930 to MTM Construction, Inc. The total approved job order is within the overall project budget and no additional funding is required.
