RECOMMENDED MOTION: That the Board of Directors:

- 1. Make the following findings pursuant to Health and Safety Code section 33445:
 - a) The construction of the Rubidoux Area 3 Sidewalk Improvement Project, Group 1 (Project) is of primary benefit to the Jurupa Valley Redevelopment Project Area (Project Area) by helping to eliminate blight within the Project Area through constructing and improving Project streets, drainage, lighting, sidewalks, curb, and gutters, in an area that currently has intermittent sidewalks and deteriorated roads:
 - b) No other reasonable means of financing the cost of the Project are available to the community due to the fact that there are no County funds available; and

- c) The payment of funds for the cost of the Project is consistent with the Implementation Plan for the Project Area and is necessary to effectuate the purpose of the Project Area's Redevelopment Plan, which calls for street improvements as needed infrastructure.
- 2. Ratify and authorize the Chairman of the Board to execute the attached Amendment to the Agreement between the County of Riverside (County) by and through the Transportation Department and the Redevelopment Agency for the County of Riverside (Agency), providing an additional \$2,923,591 in redevelopment funds for additional design, construction and construction management for Group 1 of the Project.
- 3. Authorize the Executive Director of the Redevelopment Agency or designee to execute and take all necessary steps to implement this Agreement including signing subsequent necessary and related documents to complete this transaction.

BACKGROUND: On August 9, 2005, the Redevelopment Agency for the County of Riverside Board of Directors (Board) entered into an Agreement with the County of Riverside, by and through the Riverside County Transportation Department (RCTD) to provide design services for American with Disabilities Act (ADA) sidewalks, curb ramps, street lighting, paving, and curb and gutter improvements on portions of Tilton Avenue, Briggs Street, Leigh Street, Pontiac Avenue, Rubidoux Boulevard, Fort Drive, Twining Avenue, Molino Way, 42nd Street, Mennes Avenue, Wallace Street, Capary Road, Carol Way, and Pacific Avenue, located within the unincorporated community of Rubidoux. The Project will benefit the Project Area by significantly improving the existing infrastructure and pedestrian access in an area currently characterized by intermittent sidewalks, drainage problems and dirt frontages. Street lights will be maintained by Landscaping & Lighting Maintenance District No. 89-1-Consolidated (L&LMD No. 89-1-C)

The Project was divided into two groups in order to expedite construction on streets with limited right-of-way acquisitions; all required right-of-way acquisitions within Group 1 have been obtained and Group 1 is ready for construction. Group1 includes the following streets:

BACKGROUND: (Continued)

On April 20, 2010, the Board approved the Plans and Specifications for the Project and authorized the Clerk of the Board to advertise the Project for public competitive bidding. On May 19, 2010, four bids were received and opened with Hillcrest Contracting, Inc., being the lowest responsible bidder. Two of the four bids came in under the engineer's estimated budget. The total Project budget of \$2,923,591 for Group 1 includes costs for utility coordination and relocation, construction, construction management, and surveying by RCTD. The following are the projected costs for the Project, items followed with an asterisk are for the overall Rubidoux Area 3 Project and not specific to Group 1 alone. The above mentioned activities identified with an asterisk is a not-to-exceed amount to complete those specific tasks for the entire Rubidoux Area 3 Project, and will not be requesting additional funding for Group 2.

Rubidoux Area 3, Group 2 is anticipated to begin construction in Fiscal Year 2010/11, and will include storm drain improvements on Pacific Avenue and street improvement infrastructure upgrades along portions of Tilton Avenue, 42nd Street, Twining Street, Fort Drive, Molino Way, and Pacific Avenue. Staff will return to the Board for funding of Group 2 after the design has been completed and all right-of-way easements have been secured.

Staff recommends that the Board approve the above mentioned motions, and allow the Agency and RCTD to proceed with Project construction.

FIRST AMENDMENT TO THE AGREEMENT BY AND BETWEEN THE REDEVELOPMENT AGENCY FOR THE COUNTY OF RIVERSIDE AND THE COUNTY OF RIVERSIDE FOR THE RUBIDOUX AREA 3 AND CONNING STREET SIDEWALK IMPROVEMENT PROJECTS

THIS FIRST AMENDMENT TO THE AGREEMENT ("First Amendment"), is entered into on this _____ day of ______, 2010, ("Effective Date") by and between the Redevelopment Agency for the County of Riverside ("Agency") and the County of Riverside by and through its Transportation Department ("RCTD") for the design and construction of streets, sidewalks, street lighting, and street improvements in the communities of Rubidoux, and Glen Avon.

WITNESSETH:

WHEREAS, Section 33220 of the Community Redevelopment Law permits the Agency and RCTD to cooperate and assist each other in certain redevelopment activities that are the subject of this Agreement; and

WHEREAS, the parties entered into the original Agreement on August 9, 2005 ("Agreement"), to provide street improvements including sidewalks, curb and gutter, and street lighting on portions of 42nd Street, Tilton Avenue, Briggs Street, Leigh Street, Pontiac Avenue, Rubidoux Boulevard, Fort Drive, Twining Avenue, Molino Way, Molino Avenue, and Conning Street in the communities of Rubidoux and Glen Avon (hereinafter referred to as the "Project" and demonstrated through Exhibit "A"); and

WHEREAS, The cost to design the Project was an amount not to exceed \$462,000 for the Rubidoux Area 3 sidewalk project and \$111,000 to design the Conning Street sidewalk project, for a total design budget not to exceed \$573,000; and

WHEREAS, on July 7, 2006, Item 3.68, the Board of Supervisors approved the contract with Sully Miller Contracting Company to construct the sidewalk, curb and gutter along Conning Street in the unincorporated community of Glen Avon; and

WHEREAS, on January 30, 2007, Item 3.27, the Board of Supervisors (hereinafter referred to as Board) accepted and approved the construction Notice of Completion for Conning Street; and

WHEREAS, due to right-of-way easement requirements, the Rubidoux Area 3 Project was divided into two groups, with Group 1 having obtained all required right-of-way easements; and

WHEREAS, Group 1 is comprised of the following streets: 42nd Street (Riverview Drive to the West End of Tilton Avenue), Briggs Street (Tilton Avenue to Parking Lot South of Mission Boulevard), Leigh Street (Tilton Avenue to Molino Way), Molino Way East (Leigh Street to Pontiac Avenue), Pontiac Avenue (Tilton Avenue to Mission Boulevard), Rubidoux Boulevard (Tilton Avenue to Mission Boulevard), Mennes Avenue (42nd Street to Mission Boulevard), Wallace Street (42nd Street to Mission Boulevard), Carol Way (Wallace Street to 500 Feet East of Wallace Street), Capary Road (Wallace Street to the west of Driving Range Road); and

WHEREAS, on April 20, 2010, Item 3.71, the Board approved the plans and specifications for Group 1, and authorized the Clerk of the Board to advertise the Project; and

WHEREAS, on May 18, 2010, RCTD, through a competitive bidding process, received four construction bids and subsequently selected the apparent lowest bidder Hillcrest Contracting, Inc., for an amount of \$1,965,082.40; and

WHEREAS, Agency agrees to reimburse RCTD for additional costs associated with constructing Group 1 including surveying, additional civil engineering design, right-of-way easements preparation, utility coordination, construction and construction contingency, construction management and administration, and construction survey and inspection for a total Project budget for Group 1 not to exceed \$2,923,591 (Exhibit B-1); and

WHEREAS, the total reimbursement agreement amount including the Agreement and First Amendment shall not exceed \$3,496,591.

NOW, THEREFORE, in consideration of the foregoing and providing that all other sections not amended remain intact, the parties hereto do hereby agree as follows effective August 9, 2006:

A. Section 3 of the Agreement is hereby deleted in its entirety and replaced with the following:

SECTION 3. Scope of Services. The work to be performed by RCTD, RCTD consultant(s) and RCTD contractor(s), is described in detail in Exhibit "B" and "B-1," which is attached hereto and incorporated herein by this reference. Those items identified within Exhibit "B-1" proceeded with an asterisk are for work associated with the overall Rubidoux Area 3 Project (Group 1 & 2), and are considered to be a not to exceed final cost for the duration of the Rubidoux Area 3 Project (Group 1 & 2). Future funding for those asterisked items will not be considered or granted unless approved in writing by both parties.

B. Section 4 of the Agreement is hereby deleted in its entirety and replaced with the following:

SECTION 4. The Contractor. The contractor(s) for the Project shall be selected through a competitive bidding process and awarded to the lowest responsible bidder.

C. Section 5 of the Agreement is hereby deleted in its entirety and replaced with the following:

SECTION 5. <u>Disbursement of Funds.</u> Agency shall reimburse RCTD for the actual cost to design the Project and construct Group 1, as detailed within Exhibit "B" and "B-1," for an amended amount not to exceed three million, four hundred ninety-six thousand, five hundred ninety-one dollars (\$3,496,591). Said amount shall be the maximum amount paid to RCTD for the Project.

RCTD will be reimbursed upon Agency's receipt of journal vouchers issued by RCTD for the services specified within the Agreement, Amendment,

and abovementioned exhibits. Appropriate backup documentation showing the time and material expended must be submitted with each journal voucher. All costs incurred by RCTD must be billed to Agency within 180 days from completion of services specified in this Agreement in order to receive payment. Any journal voucher received after this time will be returned to RCTD without payment.

RCTD shall obtain written approval from the Agency for any change or

alteration to the approved construction plans that require the use of contingency monies.

D. Section 7 of the Agreement is hereby deleted in its entirety and replaced with the following:

SECTION 7. <u>Principal Contact Persons.</u> The following individuals are hereby designated to be the principal contact persons for their respective Parties:

E. Section 13 of the Agreement is hereby deleted in its entirety and replaced with the following:

SECTION 13. <u>Time Limit</u>. RCTD shall commence and complete the work that is the subject of the Agreement and this First Amendment within a period of twenty-four (24) months after the date of execution of this First

Amendment. In the event said twenty-four (24) month period expires prior to the completion of the work, the terms of this Agreement and First Amendment may be extended upon written consent of both parties. Nothing in this Section shall be deemed a waiver of any or all claims or other actions by either party in regard to any breach of this Agreement.

F. Section 14 of the Agreement is hereby deleted in its entirety and replaced with the following:


SECTION 14. Entire Agreement. This Agreement and First Amendment are intended by the Parties hereto as a final expression of their understanding with respect to the subject matter hereof and as a complete and exclusive statement of the terms and conditions thereof and supersedes any and all prior and contemporaneous agreements and understandings, oral or written, in connection therewith. Any amounts to or clarification necessary to this Agreement and First Amendment shall be in writing and acknowledged by all parties to the Agreement. Each of the Exhibits attached hereto are incorporated herein by this reference.


