2) Authorize the Chairperson of the Board to sign three (3) originals of the MOU on behalf of the

BACKGROUND: Cat and Dog over-population continue to be a significant problem within the community. In 2009, 52,645 cats, dogs and other species combined, throughout the county, made their way through the County animal shelters for various reasons.

YMCA is entering into an MOU with the COUNTY from August 21, 2010 through September 21, 2010 to recognize Riverside County's Homeless Animals Awareness Month. The YMCA will give every new membership within the above mentioned dates in the month of August/September a voucher worth forty dollars (\$40.00) to use towards the adoption of an animal at one of the COUNTY Animal Shelters.

BACKGROUND (Continued): If the voucher to adopt an animal is not used by September 30, 2010, the YMCA will contribute the unused voucher amount to the COUNTY to be used in any manner within Animal Shelter Operations.

There is no way to tell how many new members the YMCA will have within August 21, 2010 through September 21, 2010, but they average 35 to 40 new membership units for the month. This would be an average of two thousand, five hundred dollars \$2,500 in monies for Animal Shelter Operations.

By October 8, 2010 the YMCA will provide to the COUNTY a final report giving the total amount of vouchers that were issued with tracking numbers, dates issued, member names, date used and name of adopter along with the check to cover the amount of the vouchers issued. The department will request a budget adjustment, if necessary, in the quarterly budget report.

CONTRACTING PARTNERS: YMCA of Riverside City & County ("YMCA")

and

County of Riverside through its Community Health Agency

Department of Animal Services ("COUNTY")

PERIOD OF PERFORMANCE: August 21, 2010 through September 21, 2010

PROGRAM: Riverside County's Homeless Animals Awareness Month

1. DESCRIPTION OF SERVICES;

YMCA is entering into this Memorandum of Understanding (MOU) with the COUNTY from August 21, 2010 through September 21, 2010 to recognize, "Riverside County's Homeless Animals Awareness Month." The YMCA will give a voucher worth forty dollars (\$40.00) with every new membership to use towards the adoption of an animal at one of the COUNTY Animal Shelters. At the end of the month of September, if the voucher to adopt an animal is not used, the YMCA will contribute the unused voucher amount to the COUNTY to be used in any manner within Animal Shelter operations.

2. RECORDS AND DOCUMENTS:

YMCA shall make available, upon written request by any duly authorized Federal, State or COUNTY agency, a copy of this MOU and such books, documents and records as are necessary to certify the nature and extent of the YMCA's costs related to this MOU. All such books, documents and records shall be maintained by YMCA for at least five years following termination of this MOU and be available for audit by the COUNTY. YMCA shall provide to the COUNTY reports and information related to this MOU.

3. **VOUCHER PROCESSING (VOUCHER SAMPLE ATTACHMENT B):**

- 3.1 August 21, 2010 through September 21, 2010, the YMCA will be issuing vouchers to members worth forty dollars (\$40.00) to go toward the adoption of an animal at one of the COUNTY Animal Shelters.
- 3.2 Vouchers will have a Tracking Number and Members Name on the face of the voucher for tracking on the "Voucher List Issued/Used," that the YMCA will generate.
- 3.3 Vouchers can be transferrable if the member chooses not to adopt an animal by writing in the person's name that the voucher is being transferred to.
- **3.4** Vouchers will show Chris Fielder as the YMCA contact person, and Angela Johnson as the Department of Animal Services contact person for inquiries and tracking purposes.
- 3.5 Vouchers must be used by September 30, 2010. The unused voucher funds will be donated to the COUNTY to be used within Animal Shelter operations.
- 3.6 When vouchers are processed at the shelter for adoption, Angela Johnson will be given the tracking number(s) and name(s) on the vouchers used. Angela Johnson will document the tracking number(s) and name(s) onto the Voucher List Issued/Used.

4. **VOUCHER LIST ISSUED/USED (ATTACHMENT A):**

- 4.1 Chris Fielder, Branch Director for YMCA will be in charge of generating the Vouchers List Issued/Used, as shown in Attachment A. The list will contain the Tracking Number, Date Issued, Member's Names, Date Used and Name of Adopter. The Voucher List Issued/Used will be sent to Angela Johnson for tracking purposes via e-mail as it is updated throughout the term of this MOU.
- **4.2** Angela Johnson, Administrative Services Analyst will be in charge of updating the Voucher List Issued/Used as vouchers are used.
- 4.3 Angela Johnson will provide a final Voucher List Issued/Used to Chris Fielder via e-mail by October 5, 2010 so that the YMCA can compile the Final Report with the check to cover the vouchers issued.

5. FINAL REPORT AND CHECK:

- **5.1** By October 8, 2010, a Final Report and check to cover the vouchers issued will be provided to Angela Johnson generated by Chris Fielder giving the total amount of vouchers that was issued with tracking numbers, dates issued, member names, date used and name of adopter.
- **5.2** Angela Johnson will submit the check and final report to Fiscal for deposit for Animal Shelter Operations.
