**SUBJECT:** Resolution No. 2010-255 Adding the Ballot Statement to the Order of Election for Riverside County Transportation Commission Ordinance No. 10-002

**RECOMMENDED MOTION:** That the Board of Supervisors: 1) Adopt Resolution No. 2010-255 Adding the Ballot Statement to the Order of Election for Riverside County Transportation Commission Ordinance No. 10-002; and 2) Direct that Resolution No. 2010-255 be filed with the election official by August 11, 2010.


**BACKGROUND:** On July 27, 2010, the Board of Supervisors adopted Riverside County Transportation Commission Ordinance No. 10-002 and ordered the proposed measure to be submitted to the voters on the November 2, 2010 general election ballot. A ballot statement, however, was not included pursuant to Elections Code Section 13119. Resolution No. 2010-255 adds the ballot statement to this order of election.

Elections Code Section 9605 authorizes the Board to amend the order of election by the filing of a resolution with the elections official no later than the 83rd day prior to the election. The 83rd day prior to election is August 11, 2010, so this addition to the order of election is timely.

3 ADDING THE BALLOT STATEMENT TO THE  
4 ORDER OF ELECTION FOR RIVERSIDE COUNTY  
5 TRANSPORTATION COMMISSION ORDINANCE NO. 10-002

6 WHEREAS, on July 27, 2010, the Riverside County Board of Supervisors adopted  
7 Ordinance No. 10-002, an Ordinance of the Riverside County Transportation Commission requesting the  
8 County of Riverside to conduct a special election on November 2, 2010 for the purpose of submitting to  
9 the electors of Riverside County a measure which would modify the commission's authorization limit to  
10 issue limited tax bonds and, if approved, would authorize such increase; and

11 WHEREAS, in accordance with Ordinance No. 10-002, the Board of Supervisors ordered  
12 the election to be called and the measure to be included on the ballot for the November 2, 2010 general  
13 election; and

14 WHEREAS, the order of election did not include the ballot statement pursuant to Elections  
15 Code section 13119;

16 NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of  
17 Riverside assembled in regular session on August 10, 2010, that pursuant to Elections Code section 9605,  
18 the order of election is amended to add the ballot statement for the measure;

19 BE IT FURTHER RESOLVED that the ballot statement to be submitted to the voters of  
20 the County of Riverside for the measure as set forth in the above-referenced ordinance shall be as follows:

Shall Ordinance No. 10-002, amending RCTC's existing 2002 voter-approved ordinance to expedite construction of the following types of transportation projects: <ul style="list-style-type: none"> <li>• Widen freeways including State Routes 91, 71, 79, and Interstates 10, 15, 215</li> <li>• Widen and improve major streets</li> <li>• Expand Metrolink commuter train services</li> </ul> by increasing bonded indebtedness from \$500 to \$975 million of estimated receipts from the Measure A program, be approved?
