Departmental Concurrence

SUBJECT: Ratify the Fifth Amendment to the Agreement #08-016 with Desert AIDS Project to provide HIV Services in Riverside County.

BACKGROUND:

The Department of Public Health, HIV Program has been actively involved in reducing and eliminating the spread of HIV disease in Riverside County through its many prevention and treatment programs. To assist in these efforts, the HIV Program utilizes community based non-profit agencies specializing in the delivery of HIV treatment and prevention programs to hard to reach and underserved populations.

On October 23, 2007, the Board of Supervisors approved item 3.7, an agreement between the Community Health Agency, Department of Public Health, HIV Program and Desert AIDS Project for the period of July 1, 2007 through June 30, 2008 with the option to renew annually through June 30, 2010. On June 24, 2008 item 3.21, the Board of Supervisors approved a renewal of this agreement and gave the purchasing agent the authority to renew the agreement annually through June 30, 2010. This Fifth Amendment will renew this agreement from July 1, 2010 to June 30, 2011 in the amount of \$210,000.

The cost of this current agreement is covered by a grant from the State Office of AIDS. The State Office of AIDS does not anticipate any further cuts in HIV prevention and treatment funds to Riverside County, however, the Community Health Agency/Department of Public Health did not want to initiate a Request for Proposal (RFP) with the uncertainty of the current state budget or interrupt the provision of these vital public services.

The Community Health Agency/Department of Public Health will initiate a Request for Proposal (RFP) for these services in FY10/11 for the period of July 1, 2011 through June 30, 2014. Therefore, the Community Health Agency/Department of Public Health is requesting the Board of Supervisors to approve this amendment for one more year until the Request for Proposal (RFP) is completed.

FIFTH AMENDMENT TO THE AGREEMENT

BETWEEN

COUNTY OF RIVERSIDE

AND

DESERT AIDS PROJECT

(Target Prevention Services)

That certain Agreement between the County of Riverside through its Community Health Agency Department of **HIV/AIDS** (COUNTY) and **Desert AIDS Project** (CONTRACTOR), approved on October 23, 2007, amended for the first time on, June 24, 2008, amended for the second time on, May 15, 2009, amended for the third time on September 30, 2009, amended for the fourth time on January 11, 2010 is hereby amended for the fifth time effective July 1, 2010 as follows:

1. To establish the amount for fiscal year 10/11 in the amount of two hundred, ten thousand, (210,000) including all expenses.
2. Amend all references to the period of performance from July 1, 2009 through June 30, 2010 to July 1, 2010 through June 30, 2011.
3. All other terms and conditions of this Agreement are to remain unchanged.
