
**SUBJECT:** Timeshare Internet Tax Sale, TC-188, scheduled on November 2, 2010

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Approve the intended timeshare internet tax sale, TC-188, 2) Approve and adopt the provisions of the Revenue and Taxation Code Section 3698.5(a), 3698.5(c) and Section 4703(a), 3) Adopt resolution 2010-246 approving the sale of tax-defaulted property prepared and approved by County Counsel, and 4) Instruct the Clerk of the Board to immediately forward a certified copy of the Board's Resolution to the Tax Collector following Board approval.

The above action will authorize the minimum bid on timeshares to be offered for sale, via the internet, scheduled for November 2, 2010.

**BACKGROUND:** Properties for which taxes are not paid are sold to collect back taxes. After the property has been tax-defaulted for a period of five or more years from the original tax-defaulted year, it becomes subject to the Tax Collector's "Notice of Power To Sell Tax-Defaulted Property", which is then recorded. If the property is not subsequently redeemed by the payment of amounts due, it is offered for sale by the Tax Collector.

**SUMMARY OF THE TIMESHARE INTERNET SALE:**

**On November 2, 2010 at 9:00 AM**, the Tax Collector will offer a total of two hundred thirty-four (234) timeshare intervals at Club Trinidad Resorts, located in Palm Springs. These timeshare intervals have been requested by prospective purchasers to be placed on the sale and to be offered as a single group. Since the resort has had some financial difficulties, these intervals are not good candidates at this time for sale to individual purchasers.

Two hundred thirty-four (234) intervals from Club Trinidad will be offered for the minimum bid of \$540.00 which is the cost of sale per interval. These intervals have been previously offered at least once and no bids were received. These intervals will be grouped and offered for a single minimum bid of \$126,360.00 (which is the cost of sale).

For this sale, if all parcels sell for the minimum bid, the maximum tax loss would be **\$151,400.22**. Taking into account the Teeter formula, which shares this loss with other taxing entities, the maximum loss to the Tax Loss Reserve Fund would be **\$82,104.34**. A sufficient balance exists in the Tax Loss Reserve Fund to allow for this loss and still transfer to the General Fund the surplus amount included in this year's budget. Therefore there is no direct budgetary impact.

8 WHEREAS, the Tax Collector of Riverside County intends to sell at public auction, over the

11 postponement of the sale that may be necessary; the Tax Sale List TC 188 Sale File 4366 is attached  
12 herewith as Exhibit "A" and sets forth the property declared tax-defaulted with the year of the tax-default  
13 and the assessment number; the notice of the proposed sale will be sent to the State Controller in  
14 accordance with Section 3700.5 of the California Revenue and Taxation Code; and

15 WHEREAS, the Tax Collector in his discretion has determined that the property specified in  
16 Exhibit "A" attached hereto and incorporated by reference, should be offered for sale on November 2, 2010  
17 with the minimum bid to be in accordance with California Revenue and Taxation Code Section 3698.5, and

18 WHEREAS, two hundred thirty-four timeshare intervals, or less, at the Club Trinidad  
19 Resorts in Palm Springs will be offered at the tax sale in a single group at a reduced bid; and

20 WHEREAS, the Tax Collector has determined that due to unique circumstances that the  
21 timeshare intervals that are being offered should be offered at a reduced bid because they have been  
22 previously offered at the full redemption price plus cost of sale and did not sell; and

23 WHEREAS, it is in the best interests of the State of California, the County of Riverside, and  
24 cities, school districts, and special districts for whom the Tax Collector collects taxes, to sell said  
25 properties; now, therefore,
