**SUBJECT:** Annual On-Call Asphalt Road Maintenance Agreement Amendment #1

**RECOMMENDED MOTION:** That the Board approves and:

1. Authorizes the Riverside County Regional Park and Open Space District (Park District) to renew the annual asphalt road maintenance agreement with Wheeler Paving, Inc. for one more year as shown on Amendment #1;
2. Authorizes the Chair of the Board to execute three copies (3) of Amendment #1 to the Agreement; and
3. Instructs the Clerk of the Board to return two (2) copies of the executed Amendment #1 to the Agreement to the Park District for further processing.

**BACKGROUND:** The Park District is responsible for managing and maintaining all of its park facilities and roads. On April 15, 2008, per Minute Order 13.2, your Honorable Board approved an Annual On-Call Asphalt Road Maintenance Agreement for Park District facilities county wide. From beyond Chiriaco Summit to Blythe, the Park District serves as the Parks Department and this Agreement would serve those areas as well. On July 1, 2008 per Minute Order 13.3, your Honorable Board executed a contract between the Park District and Wheeler Paving, Inc. in the not-to-exceed amount of \$100,000 annually for a two (2)


1. The Agreement will be extended from it's original termination date of July 1, 2010 until July 1, 2011.


