

SUBJECT: Pre-Qualified List for Consulting Firms

RECOMMENDED MOTION: That the Board of Supervisors:

- 1. Approve the establishment of the attached list of consulting firms (Attachment A) in the fields of construction management, geotechnical management, materials testing, remediation (hazardous materials), energy management, civil engineering, or land surveyors for use on an as-needed basis and with negotiated fees not-to-exceed \$100,000, per project per fiscal year; and
- 2. Approve incorporating the previously pre-qualified list of consulting firms established by Economic Development Agency (EDA) prior to the merge of EDA with Facilities Management (FM) with the list proposed as set forth in Attachment "A" for use on an as-needed basis and with negotiated fees not to exceed \$100,000 per project per fiscal year.

BACKGROUND:

On August 10, 2009, EDA advertised a Request for Qualification (RFQ) for consulting services and for the selection of various consultant related services including construction management, geotechnical management, materials testing, remediation (hazardous materials), energy management, and civil engineering or land surveyors.

The RFQ's were submitted for the purpose of developing a pool of qualified specialty consulting firms to perform project work on an as-needed basis.

Creating and building upon a pool of qualified firms is in conformance with Board Policy H-7, and is intended to enable the agency to quickly respond to client needs and accelerate the delivery of projects.

Per Board Policy H-7 and Government Code, a selection committee made up of representatives from EDA was established to review each firm's qualifications. After reviewing the submitted qualifications, sixty-seven firms were selected for consulting services on the basis of achieving at least a predetermined minimum collectively related score. Each firm offers particular strengths that apply to the different types of projects.

On April 1, 2009, EDA and FM were merged. Prior to the merge, EDA established a list of prequalified consulting firms according to Board Policy H-7 and Government Code. Motion 2 recommends incorporating EDA's previously established pre-qualified list with the firms qualified under Motion 1.

Consulting services will be retained on an as-needed basis via the issuance of a contract or purchase order for negotiated services including, but not limited to, agreement on the scope of work, terms, conditions, and compensation. The consultant services fees range from \$500 to \$100,000 per project.

Firms will be selected by project managers of EDA based on the pre-qualified firm's current workload and the firm's particular qualifications for individual projects.

In accordance with Board Policy H-7, the period of qualification for the selected firms will remain in effect for a maximum of three years from the date of Board of Supervisors approval. EDA's Project Management Division will conduct the required annual performance reviews.

For larger more complex projects, a project-specific Request for Proposal will be utilized to secure the consulting services.
