BACKGROUND: The Transportation Department needs engineering support services to deliver all the necessary road improvement projects identified and funded in the Transportation Improvement Program. The Board of Supervisors approved and executed an agreement between the County and PB Americas, Inc. on November 14, 2006. The agreement provided

that the services be performed over a three year period with the option of providing up to two one-year extensions. In 2009, the Board of Supervisors ratified and executed an amendment that extended the period of services for one year. This amendment exercises the option in the agreement to extend the term of the contract for the second one-year extension. This extension will allow the authorization of work assignments until June 30, 2011. The amendment also extends the contract termination date to June 30, 2013 to allow for the performance of all work assignments authorized prior to or on June 30, 2011.

PB Americas, Inc. is currently assisting the Transportation Department with the implementation and usage of new computer aided drafting (Microstation) and design (Inroads) software. PB Americas, Inc. is also providing constructability reviews on various transportation projects and is participating in the value analysis studies on several projects.

All associated contract costs will be funded using project funds. Thus, no net county costs will be incurred as a result of this contract amendment.

THIS AMENDMENT (hereinafter the "2 <sup>nd</sup> Amendment") to an agreement is a	made and entered into as of this			
day of, 2010, by and between the County of Riverside, a	political subdivision of the State of			
California (hereinafter the "COUNTY"), and PB Americas Inc. (hereinafter "ENGINEER").				

#### **RECITALS**

- A. COUNTY and ENGINEER have entered in an agreement entitled "On-Call Engineering Services bell County of Riverside Transportation Department and Parsons Brinckerhoff Quade & Douglas, Inc." to dated November 14, 2006 (hereinafter the "Agreement"). The Agreement provides the terms and conditions scope of work, schedule and budget for the performance of professional and technical services necessary provide on-call engineering services. On December 1, 2009, COUNTY and ENGINEER ratifical amendment to extend the authority to approve work assignment from June 30, 2009 to June 30, 2010.
- B. Appendix B Article BI establishes the time period for allowing work assignments to be authorized under the original agreement. The terms and conditions specify that work assignment can be authorized until June 30, 2009 and that the authority to approve and execute work assignments can be modified through one-year supplemental extensions. The agreement allows for two separate one-year extensions.
- C. The ENGINEER is satisfactorily performing the duties under this agreement and the Transportation Department continues to need the services provided. The parties therefore now desire to implement the second one-year extension of the authority to approve and execute work assignments. Additionally, The parties desire to amend the Agreement to extend the expiration date to allow ENGINEER to complete work assignments that were approved during the contract period but were not completed by the ENGINEER prior to the contract termination date. All work performed during the extended contract period will be subject to the original authorizations provided by the Transportation Department prior to or on June 30, 2011 and no additional budget authorization is requested.

**AGREEMENT** 

NOW, THEREFORE, in consideration of the mutual covenants hereinafter contained, the parties agree as follows:

- 1. The authority to authorize work assignments under this contract is hereby extended to June 30, 2011 effective as of June 30, 2010 in accordance with Appendix B Article BI of the original agreement.
- 2. Appendix B Article BI is amended by extending the contract termination date to June 30, 2013. All work performed in the Period between June 30, 2011 and June 30, 2013 shall be authorized prior to June 30, 2011.
- 3. Except to the extent specifically modified or amended hereunder, all of the terms, covenants and conditions of the Agreement shall remain in full force and effect between the parties hereto.
- IN WITNESS HEREOF, the parties hereto have caused this Amendment to the Agreement to be duly executed this day and year first written above.
