9 2.2329, Change of Zone Case No. 7722" which map is made a part of this ordinance.

10 Section 2. This ordinance shall take effect 30 days after its adoption.



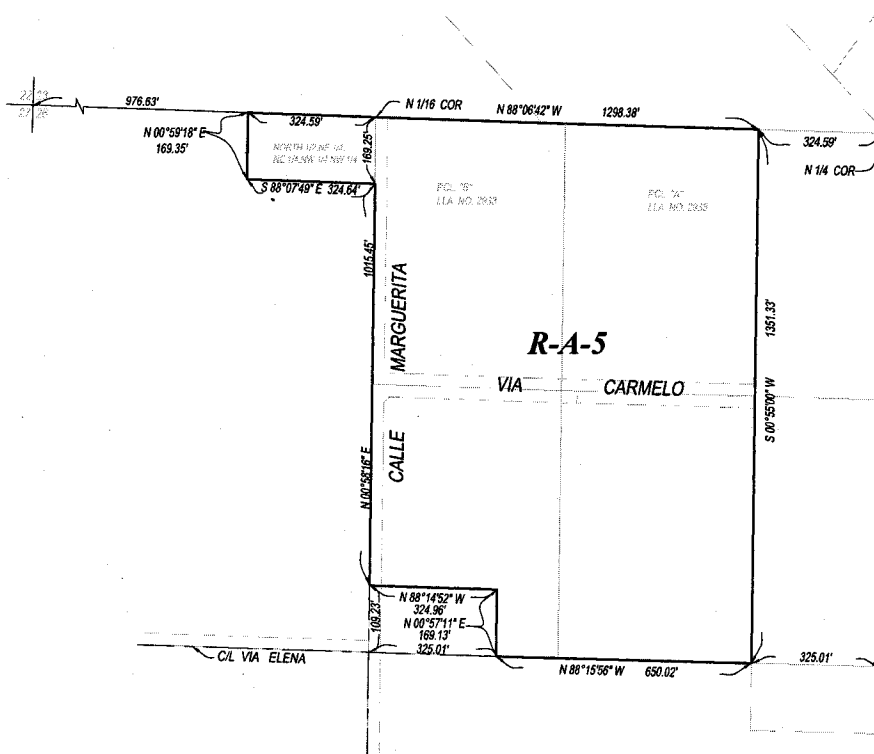

SEC. 26 T 7 S, R 1 W S. B. & M.

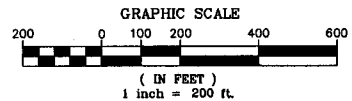
