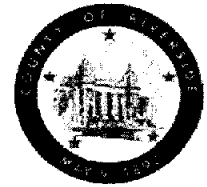

BACKGROUND: On September 1, 2010, the Mayor of Norco approved the second amendment to the city's law enforcement services agreement with the County Sheriff's Department. This amendment modifies the level of law enforcement service provided by the Department to the city with the deletion of a Community Services Officer II (CSO II) position. County Counsel has approved the amendment as to form.

This personnel action will result in the deletion of the Position Control Number 51617 for the CSO II position.

Based on the July 1, 2010 date for the service reduction, staff estimates a decrease in Contract City law enforcement revenue of \$91,000.
