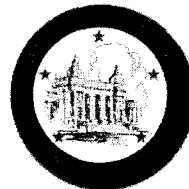

**SUBJECT:** Renewal of the Agreement with College of the Desert for Automated Library Services

**RECOMMENDED MOTION:** That the Board of Supervisors approve and authorize the Chairman to sign the Ninth Amendment to the Agreement with College of the Desert for Automated Library Services.

**BACKGROUND:** The Riverside County Network, a part of the Riverside County Library System, provides automation services to several independent but cooperating libraries within Riverside County. The services are arranged by the County Librarian and maintained with oversight by the County Librarian. Agreements for these services have been in place since 1997. This agreement keeps the same terms and cost, and extends the agreement for an additional year to June 30, 2011, at a cost of \$65,505. This agreement has been reviewed by County Counsel.

**NINTH AMENDMENT TO THE AGREEMENT  
BETWEEN THE COUNTY OF RIVERSIDE AND  
COLLEGE OF THE DESERT  
FOR AUTOMATED LIBRARY SERVICES  
(Fiscal Year 2010-2011)**

WHEREAS, the County of Riverside ("COUNTY") has entered into a contract with College of the Desert ("COD") for the provision of automated library services, as amended (the "Agreement") and both parties now agree to further amend the Agreement, to be effective on July 1, 2010:

**NOW THEREFORE**, the parties agree as follows:

A. Section 1 is amended to add the following paragraph to the end of the existing section, as amended:

"The term of this Agreement is extended to include the time period from July 1, 2010 to June 30, 2011".

B. All other terms and conditions of the Agreement, as amended, shall remain unchanged and shall remain in full force and effect.


