With regard to Case No. CV 09-05775, on October 7, 2009, the Riverside County Code Enforcement Department issued a Ten-Day Notice of Intent to Abate a substandard mobile home on the subject property, which was deemed to be an imminent hazard. On Oct. 21, 2009, a Notice of Intention to Seize was issued. On or about January 22, 2010, the substandard mobile home was abated from the subject property under the direction of the Riverside County Code Enforcement Department pursuant to a seizure warrant. Additionally, regarding Case No. CV 09-05774, the Riverside County Board of Supervisors issued an Order to Abate on February 23, 2010. On or about April 6, 2010, the property owner brought the property into compliance.

The property has a delinquent tax status as of 2010.

The Notice of Hearing re Statement of Expense has been posted on the property and mailed to the property owner and all interested parties, as required by law. Copies of all relevant notices issued in this matter together with proof of service and posting have been separately filed with the Clerk of the Board and are made a part of the record herein, pursuant to Riverside County Ordinance 725.
