**BACKGROUND:** Roadway resurfacing is needed due to deteriorated pavement conditions. The proposed road improvements include grinding the existing pavement as base where appropriate and placing new asphalt concrete pavement, constructing segments of asphalt concrete dike, and overside drains. Additional improvements include installation of detector loops, striping, pavement markings, relocation of roadway signs, adjust manholes and water valves to grade, and other associated work.

The Transportation Improvement Program provides for the resurfacing and reconstruction of Van Buren Boulevard from Barton Street to include the frontage of the Riverside National Cemetary and the associated improvements in the Orangecrest area of Riverside County. This segment of Van Buren carries over 40,000 vehicles per day.

The bid documents include the following schedules of work:

Base Bid: Primary items of work on Van Buren Boulevard.

Alternate 1: Adjustment of sewer manholes to grade, to be funded by the Western

Municipal Water District.

If the Western Municipal Water District (MWD) concurs with bid prices, as bid by the apparent low bidder, the alternate bid schedule will be included with the contract award and the costs for the work will be funded by Western MWD.

The submitted plans and specifications have been approved as to form by County Counsel.
