
RECOMMENDED MOTION: That the Board of Supervisors:

BACKGROUND:

The Salute to Veterans Parade is a family event that honors our veterans who have served in the military and deserve our recognition.

The Stephan Center will be providing an educational workshop targeting Grandparents Raising Grandchildren through the Kinship programs in the Fourth District.

The Riverside County Fire Department and RC Firefighters' Golf Associations are holding the Thirteenth Annual Burn Foundation Golf Tournament on April 22, 2011. All proceeds from the event are donated to burn patients transported to the Arrowhead Regional Medical Center in Fontana.

The Valley Partnership's AmeriCorps Promote program provides tutoring services to students in the 13 elementary schools at Coachella Valley Unified School District. The focus is literacy in kindergarten through third grade. The tutors will assist students with their reading and English fluency proficiency and science activities during classroom instruction and after school.
