BACKGROUND:

This safety project will widen the paved shoulders on two segments of El Sobrante Road and provide enhanced striping and pavement markers from La Sierra Avenue to Cajalco Road, a distance of 5.6 miles. Additionally, work on the two segments of approximately one mile each includes widening the pavement by 4-feet providing a 4-feet wide graded shoulder on each side. The widening of Segment 1 is from McAllister Street to one mile east, and widening of Segment 3 is from Mockingbird Canyon Road to Cajalco Road. This project will restripe and replace any missing pavement markings from McAllister Street to Cajalco Road. A centerline rumble strip will be placed in the curved sections of the road. Raised pavement markers will be installed from La Sierra Avenue to McAllister Street. Project segments are depicted on the attached Vicinity Map.

Specifically, the work includes sawcut, pavement removal, excavation, Class 2 aggregate base, Hot Mix Asphalt, shoulder grading, asphalt dike, overside drains, rumble strip, raised pavement markers, striping, pavement markings and associated improvements.

This project is primarily funded by a Grant of Federal Highway Administration funds under the "High Risk Rural Roads (HR3) Program". An application for shoulder improvements on segment 2, the remaining three mile segment, was not approved on first submittal and will be re-submitted for future funding. In the mean time, the County will continue the design work and will assess the availability of local funds to improve this segment in case HR3 funding does not get approved.

The County was successful in obtaining FHWA funds through a competitive process. This project will create construction jobs, improve the traffic operation and improve safety of the motorists.

The submitted plans and specifications have been approved as to form by County Counsel.

Environmental clearance is complete.


