SUBJECT: Proclamation declaring the month of April to be Child Abuse Prevention Month

BACKGROUND (Continued):

In the United States, approximately 693,174 children were found to be victims of child abuse or neglect in 2009 (U.S. Department of Health & Human Services, Children's Bureau Child Maltreatment Report 2009). In Riverside County, 58,528 calls were made to the Child Abuse Hotline, resulting in 19,685 child abuse investigations.

DPSS, District Attorney's Office, Sheriff's Department, Riverside Country Regional Medical Center, and Prevent Child Abuse Riverside County have formed a collaborative effort to promote the prevention of child abuse as well as respond to incidents of child abuse.

The County currently contracts with community-based, non-profit organizations. These organizations provide services to reduce the incidence of child abuse by helping parents resolve their issues with substance abuse, domestic violence, parenting skills, education, homemaking, and basic living skills. They County also provides prevention and early intervention services to prevent problems from intensifying, thereby reducing the need to remove children from their homes in order to ensure their safety.

It truly takes an entire community to raise and ensure the well being of a child. DPSS, RCRMC, DA, and the Sheriff's Department are proud to work with its community partners, and the many private citizens, whose efforts help to make Riverside County a safer place for our children. In support of these efforts and to increase community awareness of these issues, we join in asking the Riverside County Board of Supervisors to proclaim April 2011 as Child Abuse Prevention Month.

PROCLAMATION CHILD ABUSE PREVENTION MONTH APRIL 2011

WHEREAS, children deserve a safe, stable and permanent home in order to become productive members of our society; and

NOW, THEREFORE, LET IT BE KNOWN, that the BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, does hereby proclaim the month of April 2011 as CHILD ABUSE PREVENTION MONTH and urges all its residents to become more aware of this National, State and Countywide issue, and do what they can to prevent child abuse in their communities.
