SUBJECT: Approve the Eighth Amendment to Contract 08-055 with Animal Samaritans SPCA, Inc. for Spay/Neuter and other Clinic Services

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve the Eighth Amendment to Contract No. 08-055 between Animal Samaritans SPCA, Inc. and the County of Riverside Department of Animal Services to increase the total amount of compensation to \$110,000 for the current fiscal year; and
- 2) Authorize the Chairman to execute three (3) original copies of the Eighth Amendment on behalf of the County of Riverside.

BACKGROUND: For the past nine (9) years, the Riverside County Department of Animal Services has contracted with Animal Samaritans SPCA, Inc., a non-profit spay/neuter and adoption facility in Thousand Palms, to perform spay and neuter surgeries and other clinical services for the animals adopted from the County-run Thousand Palms and Blythe shelters. This increase is required to maintain necessary spay, neuter and other clinical services for shelter animals housed at the Coachella Valley Animal Campus and Blythe Shelter.

EIGHTH AMENDMENT TO THE AGREEMENT
BETWEEN
COUNTY OF RIVERSIDE
WITH
ANIMAL SAMARITANS SPCA, INC.
(Spay/Neuter and other Clinical Services)

That certain Agreement between the County of Riverside through its Community Health Agency Department of Animal Services (COUNTY) and Animal Samaritans SPCA, Inc. (CONTRACTOR), approved on January 22, 2008, executed by the Purchasing Agent, amended for the first time on April 1, 2008, amended for the second time on June 24, 2008, amended for the third time on July 29, 2008, amended for the fourth time on May 12, 2009, amended for the fifth time on November 24, 2009, amended for the sixth time on May 25, 2010, and amended for the seventh time on July 27, 2010, is hereby amended for the eighth time to be effective on the later date of execution by both Parties as follows:

1. The total amount of compensation for Fiscal Year 10/11 set forth in Section 2 of Exhibit B to the Agreement is increased from seventy thousand dollars (\$70,000) to one hundred ten thousand dollars (\$110,000).

2. All other terms and conditions of this Agreement are to remain unchanged.
