BACKGROUND: (Continued)

On October 21, 2008, the Board of Supervisors approved the total project budget of \$721,000 for the Riverside 911 Communication Center Generator Replacement Project; ratified the sole source construction agreement to David Richards Electric, Inc., and approved the purchase of a 500KW generator and 8,000 gallon above ground fuel storage tank from United Power Generation (formerly known as AGS).

As part of the total project budget of \$721,000, MTM Construction, Inc. removed the old generator and underground fuel storage tank through the Job Order Contract (JOC) process. Upon completion of that portion of work, the Board approved a Notice of Completion of the supplemental work portion only as required by JOC #002.

The project has been inspected and found to comply with all contract requirements. This Board action will release the balance of the contract retention funds of \$10,000 to David Richards Electric, Inc.

All costs associated with this agreement will be fully funded by Emergency Deferred Maintenance, Sheriff's Department and Riverside County Information Technology, thus no additional net county cost will be incurred as a result of this agreement.
