BACKGROUND:

The U.S. Department of Housing and Urban Development (HUD) requires that all substantial amendments to the Five-Year Consolidated Plan and the One Year Action Plan be approved by the Board of Supervisors. All new activities added to the One Year Action Plan as well as any significant increases in funding to an existing project are considered to be substantial amendments.

The projects, as described in Attachment A, have all been determined to be eligible and meet a National Objective of the CDBG program. Staff recommends approval of the new projects and the substantial amendment.

Pursuant to 24 CFR 91.105, the Economic Development Agency published a 30-day public notice notifying the public of the proposed amendments to the 2010-2011 Five-Year Consolidated Plan and the 2009-2014.

Description: The March Field Air Museum provides educational programs, workshops, research, library, and aviation related events in the newly expanded hanger facility. CDBG funds will be used to install ADA compliant ramps at two exit points to provide access to all persons.

The deteriorated roof membrane system will be removed down to the plywood base followed by the installation of a mechanically-attached membrane with flashings and other components to comprise a complete roofing system. CDBG funds will be used for materials, construction, and project management staff cost.


