SUBJECT: Approval of Amendment No.1 to the Mental Health Services Act (MHSA), Workforce Education and Training (WET) Southern Counties Regional Partnership Memorandum of Understanding (MOU) and Authorize the Director of Mental Health to approve future amendments.

RECOMMENDED MOTION: Move that the Board of Supervisors;

1. Approve MHSA, WET Southern Counties Regional Partnership MOU, Amendment No. 1 as presented, and,
2. Authorize the Director of Mental Health to sign non-substantive amendments.
3. Authorize the Chairman of the Board to sign Amendment No. 1.

BACKGROUND: The Riverside County Department of Mental Health's WET plan identifies participation in the Southern Counties Regional Partnership. This plan was approved by the state on November 20, 2008. Subsequently, on June 30, 2009, item 3.47, the Riverside County Board of Supervisors approved the MHSA, WET Southern Counties Regional Partnership MOU. The document presented today is the first amendment to this MOU which authorizes the MOU to automatically renew on an annual basis subject to the availability of funding.
