

### RECOMMENDED MOTION: (continued)

- 3) Authorize the Purchasing Agent to sign future contract amendments limited to the shifting of funds between budgetary line items as needed to facilitate the delivery of program services. Any amendments which would alter the original approved total grant award or change any given fiscal years' revenues or modify the lifetime of the grant will be brought to the Board of Supervisors for approval; and
- 4) Authorize the Chairman of the Board to Sign four (4) copies of the acceptance of Award and four (4) copies of the First Amendment with ALAC; and
- 5) Approve and direct the Auditor-Controller to adjust the budget as detailed in Schedule A, attached.

**BACKGROUND:** Death from TB is the ultimate indicator of a failure in TB control. In the United States, based on death certificate data reported by the National Center for Health Statistics, TB is estimated to cause 650 deaths a year. Accessing medical care late in the course of illness, provider diagnostic delays, presence of multi drug-resistance TB (MDR-TB), healthcare disparities, inadequate oversight of adverse effects associated with TB medications, and human immunodeficiency virus (HIV) infection are potential risk factors for TB mortality.

The studies will provide recommendations to local TB control programs for improving detection, investigation, and prevention of TB-related deaths in the United State. The data abstraction tool used in this study will be useful to local programs to evaluate deaths occurring in their jurisdiction potentially related to TB.

On March 2, 2010, Item 3.6 the Board of Supervisors approved the award #FEDS29TASK from the California Department of Public Health for the performance period of October 1, 2009 through September 30, 2011 in the amount of \$164,899. Out of this amount, \$13,002 was designated for Riverside County administrative fees and \$151,897 for ALAC. The existing award is being augmented by \$201,065 for 11/12, with \$16,438 for Riverside County administrative fees and \$184,627 for ALAC.

# FIRST AMENDMENT TO THE AGREEMENT WITH

## AMERICAN LUNG ASSOCIATION OF CALIFORNIA

(TB & HIV Testing)

That certain Agreement between the County of Riverside Community Health Agency Department of Public Health (COUNTY) and American Lung Association of California (CONTRACTOR), approved on March 2, 2010, is hereby amended for the first time effective on April 25, 2011 as follows:

- To increase the amount of compensation from one hundred fifty one thousand eight hundred ninety seven dollars (\$151,897) to three hundred thirty six thousand five hundred twenty four dollars (\$336,524) including all expenses.
- All other terms and conditions of this Agreement are to remain unchanged.
