- 1. Approve and Authorize Chair to execute Standard Agreement Amendment # 2 (AA-0910-21) 2010-2011 with the California Department of Aging.
- 2. Return four (4) Standard Agreements to the Office on Aging for further processing.

**BACKGROUND:** Standard Agreement AA-0910-21 Amendment #1 with the California Department of Aging (CDA) was approved on January 25, 2011 as agenda item 3.22. The original term of the agreement which includes ARRA funds was July 1, 2010 through June 30, 2011. Amendment # 2 changes the ending date of the original Standard Agreement AA-0910-21 to December 31, 2011. The unexpended funds from FY 2010-11 will be allowed to be carried over to FY 2011-12. We are requesting the Board to approve this contract extension. The funds will be available in FY 2011-12 after an additional amendment is executed for carryover funds. All other terms in the agreement remain in effect.
