BACKGROUND:

On June 20, 2006, Agenda Item No. 3.32, the Board approved the five-year contract with Amerisource Bergen to provide wholesale pharmaceutical drugs to Riverside County Regional Medical Center and the Community Health Agency.

BACKGROUND: (cont.)

Amerisource Bergen Corporation, located in Corona, has had an association with Riverside County as the primary pharmaceutical wholesaler capacity for the past five years. During this time they have provided services which have been beneficial to the County. This extension is needed to allow for the processing of a new Request for Proposal (RFP) to solicit additional vendors. Amerisource Bergen Corporation will maintain its current contract prices and discount structure for a period of one year.
