BACKGROUND: Government Code § 25845, Riverside County Ordinance Nos. 541(RCC Title 8), 348 (RCC Title 17), 520 (RCC Title 10), 457 (RCC Title 15) and 725 (RCC Chapter 1.16) authorize the recovery of abatement costs in public nuisance cases, the recordation of a notice of abatement lien and inclusion of abatement costs on the tax roll as a special assessment upon approval of the Board of Supervisors.

Multiple Notices of Violation were issued. Additionally, Inspection Warrant No. MISC 2007-095 was executed and filed on Nov. 8, 2007. Subsequently, on or about July 17, 2009, the cases were closed and transferred to the City of Menifee for further processing.

The property has a delinquent tax status as of 2007.

The Notice of Hearing re Statement of Abatement Costs has been posted on the property and mailed to the property owner and all interested parties, as required by law.
