EIGHTH AMENDMENT TO THE AGREEMENT BETWEEN COUTY OF RIVERSIDE AND

1. Delete the first (1st) sentence from Section 4.1 and replace with the following:

"This Agreement will be effective July 1, 2011 through June 30, 2012, and renew on an annual basis, unless terminated as otherwise provided herein."
