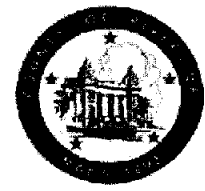

BACKGROUND: Funds provided under this Agreement support the provision of services, programs and other activities for senior citizens Countywide in accordance with Title III & Title VII of the Older Americans Act and the Older Californians Act.

The services include Supportive Services and Senior Centers (IIIB), Congregate and Home Delivered Nutrition (IIIC & NSIP), Preventive Health and Medication Management (IIID), National Family Caregiver Support (IIIE), Long Term Care Ombudsman Services (VII-a), and Elder Abuse Prevention (VII-b).

SUBJECT: FY 2011/2012 Standard Agreement AP-1112-21 between California Department of Aging (CDA) and County of Riverside for Title III/VII

The term of this agreement is July 1, 2011 through June 30, 2012 and the California Department on Aging (CDA) agreement amount total \$6,405,697.

The amount of \$6,315,861 has been already processed through the countywide recommended budget adopted by the Board of Supervisors on June 13, 2011; which reflects an underestimated amount of \$89,836 on Special Deposit and SNF Quality & Accountability Ombudsman services, therefore a budget adjustment is needed as outlined on schedule "A".

This agreement reflects the current contract from California Department of Aging and is subject to some modifications based on the State final legislative process.

There is no impact to County General Funds and we are requesting for no additional matching funds.
