**BACKGROUND:** The Transportation Improvement Program provides for the reconstruction of Gavilan Road from Multiview Drive to Hidalgo Drive, approximately 1.3 miles, and the construction of guard rail at three separate locations. 1) Gavilan Road south of Elderidge Drive, 2) Lake Mathews Drive, Capello Drive to Malta Place on northerly side, and 3) Santa Rosa Mine Road, at the transition to Gavilan Road, south of Lake Mathews Drive.

The reconstruction of Gavilan Road will consist of pulverizing the existing pavement, and placement of 0.45 feet of new asphalt concrete. From Chico Drive to Pinon Drive, sub drains and permeable base will be added to reduce pavement damage from the high water table. Concrete curb & gutter (8") will be constructed to keep the new pavement from deteriorating from water flows on the west side of Gavilan Road from Hidalgo Drive to Pinon Drive and will include concrete cross-gutters at Hidalgo Drive, Chico Drive, Esperanza Drive, Bonita Drive, Aragon Drive, Alameda Drive, Palomas Drive, Cajon Drive and Pinon Drive where these streets intersect Gavilan Road within public road right-of-way. Short segments of concrete curb & gutter will be constructed on each of the above streets to matchup to the existing curb & gutters. Work includes reconstruction of existing driveways, replacing existing AC berm, grading shoulders, reconstruct overside drains, centerline indentions (rumble strip) and new striping.

The guardrail segments on Gavilan Road, Santa Rosa Mine Road and Lake Mathews Drive and centerline rumble strip are being constructed to improve safety for motorists.

The submitted plans and specifications have been approved as to form by County Counsel.

Environmental clearance is complete.




