## **MEETINGS:**

The Riverside County Regional Park & Open-Space District Advisory Commission met bimonthly in July, September, January, March, and May in 2010-11.

- recommended approval of the transfer of Martha McLean-Anza Narrows Park to the City
  of Riverside
- approved the transfer of Quechan Park to the City of Blythe
- approved the Regional Park and Open-Space District Adopt-a-Trail Program
- approved amendments to the Park District Use Fees FY 2010-2011, Resolution 2010-1
- approved changes to Resolution 2011-4, which amends Resolution 2010-1
- approved a request from the California Waterfowl Association to host a hunter education camp for youth at Mystic Lake Duck Club in the San Jacinto Wildlife Area
- approved the draft 5-Year Strategic Plan Presentation
- approved the creation of the Strategic Plan Subcommittee
- approved the creation of the Communications Subcommittee

## COMMISSIONERS & COMMUNITY INVOLVEMENT:

The Commission met in various areas throughout the County in 2010-11, including Blythe, Riverside, and Idyllwild.

#### District I

Bill Hartford frequently visited the Santa Rosa Plateau and is very active with that facility. He was the Commission representative and spoke at the Santa Rosa Plateau ribbon cutting on March 26.

Mark Balys supported the District and represented the Commission by attending events and ribbon cuttings throughout the year.

#### District II

Ray Smith is the Public Information Officer for the County of Riverside and has assisted the Park District with media suggestions for many of its events and facilities, as well as filming at the Jurupa Boxing Club. He also supported the Wildflower Photo Contest sponsored by the Park District.

#### District II

Daniel Hake visited parks in District II including the Hidden Valley Wildlife area and Rancho Jurupa Park. He also supported the Park District at several fishing derbies at Rancho Jurupa Park, and was the Commission representative at the Lake Skinner ribbon cutting for the Jurupa Aquatics Center on May 28.

Darrell Connerton was active in his role as Commissioner by visiting Lake Skinner and other parks in District III. He supported activities for the Balloon & Wine Event at Lake Skinner each year. He was the Commission representative and spoke at the ribbon cutting on May 14



## **OVERALL COMMITTEE ACTIVITIES:**

The Committee members supported the Park District by attending events throughout the year, including but not limited to: Strategic Plan workshops; the Annual Employee/Volunteer/Support Group luncheon; ribbon cuttings for improvements at Mayflower Park; San Timoteo Canyon Schoolhouse; Santa Rosa Plateau; Lake Skinner Recreation Area; and the Jurupa Aquatics Center, The Cove; and participated in Communications and Strategic Plan subcommittees.

The Trails Committee and Park District staff assisted local communities by explaining the process of obtaining dedications and inclusion of trails on the Riverside County General Plan and the process for obtaining/utilizing

easements for trail use.

The Trails Committee continued to work on the Adopt-A-Trail Program in Riverside County.

The Trails Committee wrote a letter of support to the Southern Trails Chapter and the Utah Crossroads Chapter of the Oregon California Trails Association requesting Congress to approve a study bill that would authorize a feasibility study to determine if the Southern Historic Trail proposal meets the criteria of the National Trail Act of 1968, for designation as a National Trail.

The Committee continues to work in the best interest of trail users including hikers, bikers, equestrians, and all non-motorized users throughout the County. The Trails Committee has worked in partnership with County departments to assure the enhancement of their efforts to provide, protect, and maintain the multi-use trail systems throughout the County.

The Trails Committee expresses appreciation to the Riverside County Regional Park & Open-Space District, Riverside County Transportation and Land Management Agency, Planning, Flood Control District, and the Board of Supervisors for assisting the Trails Committee with its mission to acquire, maintain, and promote equestrian, biking, and hiking recreation trails in Riverside County.

The Board of Supervisors continued to support improvements to the Countywide Trail System throughout 2010.

The Trails Committee wishes to continue to contribute to that effort by simply doing its duty to serve the people of Riverside County by being actively involved as members of the Riverside County Trails Committee.
