**BACKGROUND:** The City of Jurupa Valley incorporated on July 1, 2011, and as part of the incorporation all of CSA 72 and 73 were included in the city. Per the Local Agency Formation Commission (LAFCO) Resolution No. 12-10 in accordance with Government Code 56886(t), the city shall have the authority to continue the levying and collection of any previously authorized charge, fee, assessment or general special tax levied within the subject territory by the county including any assessments, fees or charges by CSA 72 and 73. Per LAFCO Resolution No. 12-10 in accordance with Government Code 56886(u), the authority and responsibility for special assessment districts shall be transferred to the new city. The services provided in CSA 72 and 73 will no longer be the responsibility of the County of Riverside and no further transfer will occur. Staff met with the City of Jurupa Valley on May 4, 2011 and discussed the procedures for the transfer and responsibilities of continuing the services in CSA 72 and 73. Staff recommends approval by the Board of Supervisors to authorize the transfer of special tax balances to the City of Jurupa Valley.
